MINUTE RESOLUTION

This concerns the complaint for Violation of PD 705 filed by the DENR-CENRO, Sablayan, Occidental Mindoro, represented by Forest Ranger Jeffrey Balbin Vargas. It appears from the complaint that respondents were traversing along the National Highway, Brgy. San Vicente, Sablayan, Occidental Mindoro aboard an Isuzu stainless-type jeep coming from Sitio Cabangalan, Brgy. Pinagturilan, Sta. Cruz, Occidental Mindoro and loaded with one (1) bed and one (1) sofa bed made of narra when they were flagged down by elements of the Sablayan Municipal Police Station. After stopping the vehicle driven by respondents, the concerned police officers demanded from the former their permit for transporting the alleged "forest products". When none was presented, respondents were read of their Miranda Rights and were subsequently taken to the police station. There, an inventory of the confiscated "forest products" were made in the presence of the Mrs. Fe M. Raguindin, SEMS/Chief, MES and an employee from the DENR. A complaint for Violation of PD 705 was thereafter prepared and respondents were brought to this Office on June 16, 2021 for inquest proceedings, hence, this resolution.

From the facts obtaining, it is crystal clear that respondents did not violate the provisions of PD 705 as amended, particularly, Sec. 77 thereof as the seized bed and sofa bed cannot be considered a forest product which possession and transportation thereof is prohibited under said law without proper permit or authority from the concerned government agency.

As defined under Sec. 3 of PD 705, a forest product is defined as follows:

x x x x x

q) Forest products means timber, pulpwood, firewood, bark, tree top, resin, gum, wood, oil, honey, beeswax, nipa, rattan, or other forest growth such as grass, shrub, and flowering plant, the associated water, fish, game, scenic, historical, recreational and geologic resources in forest lands.

x x x x x

Nowhere can it be found from the above definition that a finish product of a wood or timber, such as the seized items in this case, can be considered a forest product. Since the *corpus delicti* in this case is obviously a finish product since they are already a finish furniture, a bed and a sofa bed, respondents did not violate or commit any crime particularly Sec. 77 of PD 705 as amended. In view thereof, no probable cause exists in the complaint to warrant the filing of a case in Court, hence, its dismissal is in order.

WHEREFORE, foregoing considered, the instant complaint is hereby **DISMISSED** for lack of probable cause. Corollary thereto, respondents are hereby ordered released from custody of the law and the seized items consisting of a bed and a sofa bed is likewise ordered released to its legal owner.

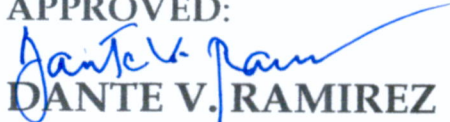

FACTS OF THE CASE:

Joint Operation headed by the PCMS Rommel Ramirez under direct supervision of the undersigned and personnel of DENR Sablayan led by Jeffrey Balbin Vargas-Forest Ranger conducted anti-illegal logging operations as per information given by the concerned citizen which resulted to the arrest of the above-name suspects for Violation of PD 705 while caught in the act transporting forest finished product without pertinent documents. Recovered from the immediate possession of the suspects on board a Isuzu stainless type jeep without plate number were One (1) piece of Sofa bed 6 feet long and One (1) piece of Bed 60x75 inches all made of Narra species valued amounting to Forty Thousand (Php 40, 000.00) Pesos. Arrested persons were apprised of their Constitutional Rights (Miranda Doctrine) and Anti-Torture Law. Further, the aforesaid confiscated items were inventoried by the personnel of DENR of this municipality.

Base on the foregoing facts, a case for Violation of PD 705 will be brought to the attention of inquest prosecutor for scrutiny and recommendation.
