ALLEGED ILLEGAL CONDUCT OF SAND, STONE AND
PEBBLE PICKING ACTIVITIES WITHIN THE BEACH
SHORE OF BARANGAY BANILAD, PINAMALAYAN,
ORIENTAL MINDORO**

We are respectfully forwarding the attached documents regarding the above subject with **Ticket Reference No. PCC Code No. GL-CYR-05-31-2021-043.**

Please be informed that in a Memorandum dated 08 June 2021, this Office requested the PENRO and Concurrent Acting PMRB Chairperson-Oriental Mindoro to conduct a site investigation regarding the matter.

In a Memorandum dated 11 June 2021, the PENRO – Oriental Mindoro forwarded to this Office a copy of the Investigation Report dated 27 April 2021 by CENRO - Socorro re: *"Investigation Report on the Video Posted on Facebook regarding the Illegal Quarry of Sand at Brgy. Banilad, Pinamalayan, Oriental Mindoro."*

Based on the said investigation report, Mr. Joseph Delos Santos and Mr. Marvie Delos Santos et. al., residents of Barangay Banilad, are engaged in the illegal beach sand extraction in the shoreline areas of Barangay Banilad, Pinamalayan, Oriental Mindoro.

In view thereof, the following recommendations/actions were made:

1. The Punong Barangay of Barangay Banilad warned the above mentioned individuals that the said activity is illegal and instructed them to immediately return the collected beach sand materials in the area.

**"MINING SHALL BE PRO-PEOPLE AND PRO-ENVIRONMENT
IN SUSTAINING WEALTH CREATION AND IMPROVED QUALITY OF LIFE."**

2. MGB-MIMAROPA issued a Cease and Desist Order dated 14 June 2021 to the above mentioned individuals in violation of *Batas Pambansa Blg. 265* or "*An Act Prohibiting the Extraction of Gravel and Sand from Beaches and Providing Penalties Therefor*".
3. MGB-MIMAROPA released a Letter of the same date to the complainant informing the result of the investigation.
