I. PRELIMINARIES

The meeting started at 02:06 in the afternoon with the singing of the Philippine National Anthem followed by an invocation and MIMAROPA Hymn.

II. BUSINESS PROPER

A. Declaration of Quorum

Ms. Sheryll B. Sarabia of NEDA MIMAROPA called the roll and declared a quorum. Of the 34 members, nine were present and 17 were represented registering 76.47% attendance.

B. Welcome Remarks and Messages

In her welcome message, RDC Special Regional Sub-Committee on the SDG Chairperson and NEDA MIMAROPA OIC-Regional Director Susan A. Sumbeling, welcomed the members and guests present. She said that the government conducted efforts and initiatives from the national to sub-national levels to ensure the achievement of the goals of the 2030 Agenda for Sustainable Development. In this context, the SDG were considered in the formulation and updating of the MIMAROPA Regional Development Plan (RDP) 2017-2022.

Dir. Sumbeling informed the members that the Social Development Committee (SDC) under the National Economic and Development Authority (NEDA) Board and the Executive Technical Board (ETB) of the Development Budget Coordination Committee (DBCC) expressed

support and agreement to the creation of the Sub-Committee on the SDG during a joint meeting held on December 19, 2018, considering the need for better coordination of the implementation of SDG programs in the Philippines. The NEDA MIMAROPA, as Secretariat of the MIMAROPA Regional Development Council (RDC), was directed to facilitate the creation of the Special Regional Sub-Committee on the SDG.

C. Proposed Agenda

On motion duly seconded, the proposed agenda was approved as presented.

D. Matters for Approval/Review/Endorsement

- Creation of the Regional Development Council (RDC) Special Regional Sub-Committee on the Sustainable Development Goals (SDG) and SDG Technical Working Groups (TWGs)

Dir. Sumbeling presented the terms of reference (TOR) for the creation of the RDC Special Regional Sub-committee on the Sustainable Development Goals (SDG) and SDG Technical Working Groups (TWGs) approved by the RDC.

The presentation included the following: a) objective of the Special Regional Sub-committee on the SDG; b) structure, roles, and functions of the Special Regional Sub-Committee on the SDG, SDG TWGs, and SDG Secretariat; c) mechanism for monitoring and evaluation; d) frequency of meetings; and e) sources of funding.

To effectively advocate and support the attainment of the SDG targets, the Special Regional Sub-committee on the SDG is chaired by the Regional Director of the NEDA MIMAROPA and co-chaired by the Regional Director of DBM MIMAROPA.

The Special Regional Sub-committee on the SDG is composed of the following members: a) CCC; b) BLGF MIMAROPA; c) DA MIMAROPA; d) DEPED MIMAROPA; e) DOE; f) DENR MIMAROPA; g) DFA - Regional Consular Office; h) DOH MIMAROPA; i) DHSUD MIMAROPA; j) DICT Luzon Cluster 3; k) DILG MIMAROPA; l) DOLE MIMAROPA; m) DOST MIMAROPA; n) DSWD MIMAROPA; o) DTI MIMAROPA; p) DOTr; q) NNC MIMAROPA; r) OCD-RDRRMC MIMAROPA; s) PCW; t) PSA MIMAROPA; u) PMS-Regional Field Unit MIMAROPA; v) Provincial/City Planning and Development Coordinators (P/CPDCs); and x) private sector representatives (PSRs).

The Policy Formulation and Planning Division of the NEDA MIMAROPA will serve as Secretariat to the SDG Special Regional Sub-Committee.

Dir. Sumbeling said that the Special Regional Sub-committee may create TWGs to facilitate and prepare technical matters relative to its functions and act on matters needing immediate attention as it

receives guidance and instructions from the Special Regional Sub-Committee on the SDG. Four SDG TWGs were created for the following sectors: a) economic; b) environment; c) social; and d) peace, security, and governance.

The economic TWG will be chaired by the Regional Director of DTI MIMAROPA and composed of the following members: BSP Lucena Branch, BLGF MIMAROPA, CHED MIMAROPA, DA MIMAROPA, DBM MIMAROPA, DOE, DENR MIMAROPA, DICT Luzon Cluster 3, DILG MIMAROPA, DOLE MIMAROPA, DPWH MIMAROPA, DOT MIMAROPA, DOTr, NYC, PCW, PSA MIMAROPA, TESDA MIMAROPA, GSIS, SSS, P/CPDOs, and PSRs.

The environment TWG will be chaired by the Regional Director of DENR MIMAROPA and composed of the following members: DOE, DPWH MIMAROPA, DOTr, LWUA, NEA, NWRB, DBM MIMAROPA, BLGF MIMAROPA, BFAR MIMAROPA, DTI MIMAROPA, DOH MIMAROPA, DHSUD MIMAROPA, DOT MIMAROPA, DILG MIMAROPA, DOST MIMAROPA, DFA-Regional Consular Office, DOLE MIMAROPA, DEPED MIMAROPA, OCD-RDRRMC, NNC MIMAROPA, CHED MIMAROPA, NCIP MIMAROPA, PSA MIMAROPA, CCC, PNVSCA, P/CPDOs, and PSRs.

The social TWG will be chaired by the Regional Director of DEPED MIMAROPA and composed of the following members: BSP Lucena Branch, CHED MIMAROPA, POPCOM MIMAROPA, DA MIMAROPA, DAR MIMAROPA, DBM MIMAROPA, DENR MIMAROPA, DHSUD MIMAROPA, DILG MIMAROPA, DOLE MIMAROPA, DSWD MIMAROPA, NCIP MIMAROPA, NFA Region 4, NNC MIMAROPA, NYC, OCD-RDRRMC, DOH MIMAROPA, PCW, PSA MIMAROPA, TESDA MIMAROPA, PhilHealth, SSS, GSIS, PNVSCA, P/CPDOs, and PSRs.

The peace, security, and governance TWG will be chaired by the Regional Director of DILG MIMAROPA and composed of the following members: BLGF MIMAROPA, CSC Region 4, COMELEC MIMAROPA, CHR MIMAROPA, DBM MIMAROPA, DENR MIMAROPA, DFA-Regional Consular Office, DOJ-Office of the Regional State Prosecutor 4, DSWD MIMAROPA, OCD MIMAROPA, PCW, PDEA MIMAROPA, PMS-Regional Field Unit, PNP MIMAROPA, P/CPDOs, and PSRs.

All four SDG TWGs are co-chaired by the NEDA MIMAROPA Regional Director.

The Project Monitoring and Evaluation Division (PMED) of NEDA MIMAROPA shall ensure that all SDG indicators in the MIMAROPA RDP 2017-2022 Midterm Update Results Matrix (RM) will be assessed and considered in the preparation of the RDR.

The Special Regional Sub-Committee on the SDG may meet as often as necessary but not less than once a semester. The Sub-Committee shall submit to the RDC its proposed maintenance and other operating expenses (MOOE) budget. The initial MOOE requirements shall be

provided by the MIMAROPA RDC until such time that its budget is institutionalized or made regular.

- SDG Related Indicators Included in the Regional Development Plan 2017-2022 Midterm Update Revalidated Results Matrix (RM)

Ms. Sarabia presented the list of SDG related indicators included in the RDP 2017-2022 Midterm Update Revalidated RM.

Then Socioeconomic Planning Secretary Ernesto M. Pernia signed Memorandum Circular (MC) No. 01, s. 2019 on April 29 directing the updating of the Philippine Development Plan (PDP), Public Investment Program (PIP), RDPs, and Regional Development Investment Programs (RDIPs) for 2017-2022.

MC No. 01, s. 2019 provides that the NEDA shall coordinate the mid-term updating of the PDP and its accompanying Results Matrix (RM) for 2017-2022. This serves as guidelines to facilitate the RM updating which shall include revalidation of indicators.

The NEDA MIMAROPA conducted a regional consultation on the formulation of the MIMAROPA RDP 2017-2022 Midterm Update and revalidation of RM on June 04-05, 2019 in Tagaytay City, which was participated in by planning officers and senior technical staff of regional line agencies, government-owned and controlled corporations, and state universities and colleges, representatives from local government units, and private sector representatives.

The MIMAROPA RDP 2017-2022 RM was revalidated to update the 2019-2022 targets based on updated information and lessons learned during the first half of the Plan's implementation, while taking into consideration the following: a) Sustainable Development Goal indicators (SDGis); b) SDGis with provincial disaggregation; and c) Core Regional Indicators (CoRe Is).

The RDC, during its 68th Full Council Meeting held on September 06, 2019 in Pasay City, passed RDC Resolution adopting the Regional Development Plan 2017-2022 Revalidated Results Matrix.

Ms. Sarabia said that for SDG related indicators with no baseline data and annual plan targets, concerned agencies may update their annual plan targets. Performance of these indicators was included in the Regional Development Report (RDR), the annual assessment of the implementation of the RDP.

A total of 85 SDG related indicators was included in the RDP 2017-2022 Revalidated RM. This included the following: a) 12 SDG related indicators in SDG 1; b) four SDG related indicators in SDG 2; c) 13 SDG related indicators in SDG 3; d) 23 SDG related indicators in SDG 4; e) four SDG related indicators in SDG 5; f) one SDG related indicator in SDG 6; g) two SDG related indicators in SDG 7; h) seven SDG related indicators in SDG 8; i) seven SDG related indicators in SDG 9; j) four SDG related indicators in SDG 11; k) one SDG related

indicator in SDG 12; l) three SDG related indicators in SDG 13; m) one SDG related indicator in SDG 14; n) one SDG related indicator in SDG 15; and o) two SDG related indicators in SDG 16.

- Update on SDG Related Indicators Included in the Provincial Results Matrix (PRM)

Dir. Sumbeling informed the Sub-committee that NEDA MIMAROPA provided technical assistance during the conduct of provincial orientation and workshop of formulation of the Provincial Results Matrix (PRM). The localization activity provides venue for provinces, cities, and municipalities to formulate provincial matrices consistent on the regional RMs and in consideration of SDG priorities.

The DILG MIMAROPA, as the overall in-charge in ensuring preparation and submission of localized results matrices by the provinces, regularly monitors the LGU compliance and submission of required forms.

Mr. Whalee F. Ferrera of DILG MIMAROPA reported the status of PRM progress monitoring form submitted by the five provinces to DILG.

In 2018, only the province of Occidental Mindoro submitted signed PRM progress monitoring form required by DILG-BLGD. While, the four provinces submitted different forms/unsigned PRM progress monitoring forms. The PRMs submitted by Marinduque, Occidental Mindoro, Palawan, and Romblon were endorsed by their respective Sangguniang Panlalawigan.

Mr. Ferrera informed the Sub-committee that the DILG Memorandum dated July 14, 2020 provides extension of deadlines for submission of plan-related documents and conduct of activities including the submission of the PRM Progress Monitoring for FY 2019 due to challenges encountered by the LGUs including the DILG field operations during the Coronavirus Disease 2019 (COVID-19) pandemic. The extended deadline is August 30, 2020.

In 2019, the provinces of Occidental Mindoro, Oriental Mindoro, and Palawan submitted PRM progress monitoring forms (excel file) to DILG. Among the three provinces, only Palawan submitted signed report but different progress monitoring form. The remaining provinces were reminded to submit their respective PRM progress monitoring forms. Other oversight agencies will be provided with the reports submitted by the provinces.

Mr. Ferrera informed the Sub-Committee that per DILG Central Office (CO) initial guidance, the conduct of provincial workshops for FY 2021 will no longer be funded by the DILG. The DILG CO has developed an electronic local development investment program or "E-LDIP System", an online portal that will be launched in 2021 which features the tagging of programs, projects, and activities using PRM codes or indicators

317 Dir. Sumbeling inquired on the evaluation process conducted by the
318 DILG MIMAROPA with the PRM progress monitoring forms submitted
319 by the provinces. She explained that the reports contain provincial
320 level data on the actual performance versus the specified targets.

321
322 Mr. Ferrera answered that the DILG MIMAROPA does not evaluate the
323 reports but only monitors the submission of the PRM progress
324 monitoring forms, which are directly forwarded or submitted to the
325 DILG-Bureau of Local Government Development (DILG-BLGD).

326
327 Dir. Sumbeling requested DILG MIMAROPA to submit summary of
328 PRM progress monitoring reports submitted by the province to the
329 Secretariat.

330
331 Ms. Marian M. Cunanan requested to update the list of provinces that
332 have submitted PRM progress monitoring forms for FY 2019. She
333 emphasized that they submitted the said form to DILG Marinduque
334 Provincial Office.

335
336 Ms. Sarabia inquired on the schedule of the localization activity in FY
337 2020.

338
339 Mr. Ferrera answered that the DILG CO has yet to provide them update
340 on the schedule of the localization activity in FY 2020.

341
342 ARD Bernardino A. Atienza, Jr. of NEDA MIMAROPA inquired on the
343 preparation of provincial development reports to assess the
344 implementation of their local development plan, including the progress
345 report on the attainment of the SDG.

346
347 Dir. Sumbeling said that some of the provinces prepare annual report
348 or conduct state of the province address, a localized version of State
349 of the Nation Address (SONA), where achievements and programs of
350 action in respect of government's priorities were reported. However,
351 in this case, the DILG monitors the performance of indicators in the
352 PRMs including the SDG indicators.

353
354 Mr. Rodne R. Galicha of Bayay Sibuyanon, Inc. inquired on the
355 possible inclusion of additional indicators in SDG 13 (Climate Action),
356 particularly on indicators relative to Nationally Determined
357 Contributions (NDC). He explained that as part of the 2015 Paris
358 Agreement, the Philippines committed to reduce greenhouse gas
359 emission. The NDC embody efforts by each country to reduce national
360 emissions and adapt to the impacts of climate change. The NDC is a
361 whole nation approach intended to be the Philippines' investment
362 strategy for a low-carbon development.

363
364 Mr. Galicha added that the NDC was consulted among the general
365 public, government, civil society organizations, academe, and the
366 private sectors at the national level, however, it was not localized
367 down to sub-national level. He said that the enhanced NDCs will be
368 delivered to the UN climate convention before the year's end. He
369 suggested that NEDA will consider the NDC in next
370 formulation/updating of regional development plan.

371 Dir. Sumbeling said that House of Representatives' Committee on
372 Climate Change is still reviewing the commitment of the Philippines
373 regarding the reduction of greenhouse gas emission or the NDC.
374

375 She added that discussion on carbon pricing is still on-going, except
376 for the excise and value added taxes on imported coal included in Tax
377 Reform for Acceleration and Inclusion (TRAIN) law. Hence, the NDC
378 was not considered in the midterm updating of the PDP or the RDP.
379 Indicators relative to reduction of greenhouse gas emission has yet to
380 be considered in the next planning cycle.
381

382 • Update on CoRe Sustainable Development Goals (SDG) Watch
383

384 Ms. Liezl L. Magbojos of PSA MIMAROPA presented the Core
385 Regional (CoRe) Sustainable Development Goals (SDG) Watch as of
386 September 15, 2020.
387

388 PSA Resolution No. 12, s. 2019 provides the initial list of core regional
389 SDG indicators (CoRe SDGs) based on the official list of the
390 Philippine SDG indicators for initial monitoring. The initial set of CoRe
391 SDGs consist of 72 indicators (with duplication per goal and target).
392 The PSA, through the Regional Statistical Services Office, shall
393 compile and disseminate the CoRe SDGs at least on an annual basis.
394

395 Ms. Magbojos informed the Sub-committee on the following: a) actual
396 data at the national-level were adapted to all indicators without
397 regional disaggregated data; and b) actual accomplishment of
398 indicators was based on the latest available data.
399

400 For SDG 1, indicator 1.2.1 (proportion of population living below the
401 national poverty line) in regional showed significant decline in 2018
402 with 15.1% from 2015's poverty incidence among population of 25.2%.
403

404 In 2017, the following performance of indicators were recorded in the
405 region: a) indicator 1.4.1p1 (percentage of women ages 15-49 who
406 received antenatal care from skilled health personnel for the most
407 recent birth) with 92.9%; b) indicator 1.4.1p2 (percentage of women
408 ages 15-49 with a live birth delivery who were assisted by skilled
409 health personnel) with 68.6%; and c) indicator 1.4.1p3 (percentage of
410 women ages 15-49 with a post-natal check-up in the first two days
411 after birth) with 86.4%.
412

413 In 2018, the following performance of indicators were recorded in the
414 region: a) indicator 1.5.1.1 (the number of deaths attributed to
415 disasters per 100,000 population) with 0.37; b) indicator 1.5.1.2 (the
416 number of missing persons attributed to disasters per 100,000
417 population) with 0.05; c) indicator 1.5.1.3 (the number of directly
418 affected persons attributed to disasters per 100,000 population) with
419 12,890 affected persons; and d) indicator 1.5.4 (proportion of local
420 governments that adopt and implement local disaster risk reduction
421 strategies in line with national disaster risk reduction strategies) with
422 100%. These indicators were also identified in SDG 11 and 13.

For SDG 2, the following performance of indicators were recorded in the region in 2018: a) indicator 2.2.1 (prevalence of stunting among children under 5 years of age) with 35.2; b) indicator 2.2.2.1 (prevalence of malnutrition for children under 5 years-wasting) with 6.9%; c) indicator 2.2.2.1 (prevalence of malnutrition for children under 5 years-overweight) with 1.8; c) 2.2.s1.1 (prevalence of micronutrient deficiencies (vitamin A deficient) under 6 months to 5 years and 60 years old and up) with 8.4 and 2.0, respectively; d) indicator 2.2.s1.2 (prevalence of micronutrient deficiencies (anemia) under 6 months to 5 years, lactating, and 60 years old and up) with 11.3, 10.5, and 19.8, respectively; and e) indicator 2.2.s2 (prevalence of exclusively breastfed children 0 to 5 months old) with 48.8.

For SDG 3, the following performance of indicators were recorded in the region in 2017: a) indicator 3.1.2 (proportion of births attended by skilled health personnel) with 68.6%; b) indicator 3.1.s1 (proportion of births delivered in a health facility) with 65.9%; c) indicator 3.2.1 (under-five mortality rate per 1,000 livebirths) with 33.0%; d) indicator 3.2.2 (neonatal mortality rate per 1,000 livebirths) with 13.0%; d) infant mortality rate per 1,000 livebirths) with 28.0; e) indicator 3.7.1 (proportion of women of reproductive age (15-49 years) who have their need for planning satisfied with modern methods) with 61.7%; f) indicator 3.7.2 (adolescent aged 15-19 years birth rate per 1,000 women in that age group) with 47.0%; g) indicator 3.7.s1 (contraceptive prevalence rate) with 50.8%; and h) indicator 3.b.1.p1 (proportion of fully immunized children) with 48.3%.

In 2018, the following performance of indicators were recorded in the region: a) indicator 3.3.1.p1 (number of HIV infections) with 198; b) indicator 3.3.2 (tuberculosis incidence per 100,000 population) with 347; c) indicator 3.3.3 (malaria incidence per 100,000 population) with 161; d) indicator 3.4.1 (mortality rate attributed to cardiovascular disease, cancer, diabetes or chronic respiratory disease) with 4.1%; e) indicator 3.6.1 (death rate due to road traffic injuries) with 14.3%; f) indicator 3.8.s1 (percentage of population covered by the social health insurance) with 69.5%; g) indicator 3.9.3 (mortality rate attributed to unintentional poisoning) with 0.3%; and h) indicator 3.a.s1 (prevalence of current tobacco use of 10-19.9 years old and 20 years old and over) with 3.3% and 20.2%, respectively.

For SDG 4, the following performance of indicators were recorded in the region in 2018: a) indicator 4.1.s1.1 (completion rate of elementary students) with 94.8%; b) indicator 4.1.s1.2 (completion rate of secondary students) with 83.2%; c) indicator 4.1.s2.1 (cohort survival rate of elementary students) with 95.4%; d) indicator 4.1.s2.2 (cohort survival rate of secondary students) with 84.6%; e) indicator 4.1.s3.1 (dropout rate or school rate in elementary students) with 0.87%; f) indicator 4.1.s3.2 (dropout rate or school rate in secondary students) with 5.4%; g) indicator 4.2.2 (participation rate in organized learning) with 71.4%; h) indicator 4.3.s1 (net enrolment rate in elementary education) with 91.0%; i) indicator 4.3.s2 (net enrolment rate in secondary education (junior and senior high school)) with 79.7% and 48.1%, respectively; j) indicator 4.3.s3 (passing rate in licensure

exam) with 35.8%; and k) indicator 4.3.s4 (certification rate (TVET)) with 91.9%.

In 2019, indicator 4.c.s2 (number of TVET trainers trained) recorded 413 TVET trainers trained in the region.

For SDG 5, the following performance of indicators were recorded in the region in 2019: a) indicator 5.5.1.1 (proportion of seats held by women in national parliamentary) with 25.0%; b) indicator 5.5.1.2 (proportion of seats held by women in local government) with 22.7%; and c) indicator 5.5.2 (proportion of women in managerial positions) with 22.4%.

For SDG 8, the following performance of indicators were recorded in the region in 2018: a) indicator 8.1.1 (annual growth rate of real GRDP per capita) with 6.4%; and b) indicator 8.2.1 (annual growth rate of real GRDP per employed person) with 9.4%.

In 2019, indicator 8.5.2 (unemployment rate) recorded 4.4% in the region.

For SDG 9, the following performance of indicators were recorded in the region in 2018: a) indicator 9.1.2.1 (passenger volume, maritime sector) with 10.85 MT; b) indicator 9.1.2.2 (container volume, maritime sector) with 80,207 twenty-foot equivalent unit; c) indicator 9.1.2.3 (cargo volume, maritime sector) with 8.22 MT; d) indicator 9.1.2.4 (passenger volume, aviation sector) with 2.98 MT; e) indicator 9.1.2.5 (cargo volume, aviation sector) with 24,506 MT; f) indicator 9.2.1 (manufacturing value added as a proportion of GRDP and per capita) with 5.1%; and g) indicator 9.2.2 (manufacturing employment as a proportion of total employment) with 5.9%.

For SDG 11, indicator 11.1.1p1 (proportion of urban population who are informal settlers) recorded 3.1% in the region in 2015.

For SDG 16, the following performance of indicators were recorded in the region in 2018: a) indicator 16.1.s1 (number of murder cases) with 165 murder cases; and b) indicator 16.1.s2 (monthly average index crime rate) with 3.9%.

Data on indicators included in SDG 6, 7, 10, 12, 13, 14, 15, and 17 had no regional-level disaggregation. Among the 15 agency/data sources of SDG indicators, PSA provided the highest contribution of data with 50.77%.

The following were the issues and concerns identified in the gathering and compilation of data on SDG indicators: a) vague targets to achieve; b) no regional disaggregation; and c) changing agency/data sources.

In line with the RSC Resolution No. 2019-04, which enjoins national and local government entities in MIMAROPA to establish statistical units and/or positions, Ms. Magbojos encouraged partner agencies to

assign permanent focal person and establish/maintain database relative to SDG indicators.

As of first quarter of 2019, the following were the statistical positions in the LGUs: a) two statistical plantilla items in Marinduque; b) three statistical plantilla items and one designated statistical position in Occidental Mindoro; c) eight statistical plantilla items and 29 designated statistical positions in Oriental Mindoro; d) six statistical plantilla items in Palawan; and e) one statistical plantilla item and two designated statistical positions in Romblon.

Ms. Magbojos said that there is a need for the timely submission of performance of SDG indicators by agency/data sources to track the progress of the achievement of the SDG in the region.

Mr. Galicha suggested that the PSA should review the CoRe SDG indicators under SDG 13 (Climate Change), which covers indicators relative to strategies on disaster risk reduction preparedness, mitigation, action plans, and climate change adaptation. He commented that only indicators relative to response strategy were included.

He added that there is a need to determine the contribution of the region and LGUs in the emission of greenhouse gas in the national level. He said that the PSA should consider the inclusion of the following indicators in SDG 13 for monitoring: a) contribution of the region and LGUs in the emission of greenhouse gas; and b) number of LGUs with local climate change action plan (LCCAP).

Dir. Sumbeling commented that the PSA may refer this concern to CCC as the lead agency to coordinate, monitor and evaluate the programs and action plans of the government relating to climate change. The CCC, in partnership with DILG, may provide assistance in the preparation of the targets and accomplishments of indicators relative to climate change.

In the updating of the preliminary result of the CoRe SDG Watch, Ms. Sarabia requested the PSA to include remarks on the report specifying the following: a) indicators with no regional/provincial disaggregation; b) indicators with regional/provincial disaggregation but update has yet to submit by the agency/data source.

Dir. Sumbeling suggested to exclude all indicators without regional disaggregation in the updating of CoRe SDG Watch and use the proxy indicators with regional disaggregation that are available.

Mr. Rodne inquired on the complementation of the indicators included in the CoRe SDG Watch with the SDG related indicators included in the RDP 2017-2022 Midterm Update Revalidated RM.

Ms. Sarabia answered that the result of the CoRe SDG Watch reported by the PSA was the data used in the preparation of the RDR, the annual assessment of the implementation of the RDP. Said data were compared to the annual plan targets of the SDG related indicators included in the RDP. For monitoring purposes, the PSA may include

other SDG related indicators, which are readily available at the regional/provincial level.

Mr. Darius M. Guerrero of PTWGO added that the review of list of SDG indicators and strategies to ensure the attainment of SDG indicators may be further discussed during the subsequent SDG Sub-Committee and SDG TWG meetings.

III. ADJOURNMENT

A. Closing Remarks

In closing, NEDA MIMAROPA OIC-Assistant Regional Director Bernardino A. Atienza, Jr. thanked the participants for their active participation and hoped for the activation of TWGs during the succeeding meetings to ensure attainment of the 17 SDG goals and targets.

The meeting was adjourned at 04:45 PM.

Subject: Update on SDG Related Indicators Included in the Regional
Development Plan 2017-2022 Midterm Update Revalidated
Results Matrix (RM)

1. NEDA Memorandum Circular No. 01, s. 2019 directs the updating of the Philippine Development Plan (PDP), Public Investment Program (PIP), Regional Development Plans (RDPs), and Regional Development Investment Programs (RDIPs) for 2017-2022. Further, it directed the NEDA to coordinate the mid-term updating of the PDP and its accompanying RMs for 2017-2022.
2. The NEDA MIMAROPA conducted a regional consultation on the formulation of the MIMAROPA RDP 2017-2022 Midterm Update and revalidation of RM in June 04-05, 2019, in Tagaytay City.
3. The RDC, during its 68th Full Council Meeting held on September 06, 2019, in Pasay City, passed RDC Resolution adopting the Revalidated RDP 2017-2022 Midterm Update Results Matrix (RM). The revalidation process of the said RM considered the following: a) Sustainable Development Goal indicators (SDGis); b) SDGis with provincial disaggregation; and c) Core Regional Indicators (CoRe Is).
4. The NEDA MIMAROPA, as the RDC Special Regional Sub-Committee on the Sustainable Development Goals (SDG) Secretariat, presented the 85 SDG-related indicators included in the Regional Development Plan 2017-2022 Revalidated RM during the organizational meeting on December 09, 2020, virtually through Zoom.
5. The NEDA MIMAROPA, as the RDC Secretariat, prepares the MIMAROPA Regional Development Report (RDR) which provides an annual assessment of the MIMAROPA RDP implementation. It contains an assessment of the socioeconomic performance of the region for a given year based on the goals and strategies of the MIMAROPA RDP and target indicators in the RM.
6. The RDC, during its 75th Full Council Meeting held on June 04 virtually through Zoom, reviewed and approved the 2020 RDR. There are 85 SDG-related indicators included in the results matrix: 42 indicators fell below the target; 24 indicators exceeded the target; seven indicators attained the target; nine indicators have no 2020 updated data yet; and three indicators have no point of comparison between 2020 target and actual data.
7. The Secretariat will present update on SDG related indicators included in the Regional Development Plan 2017-2022 Midterm Update Revalidated Results Matrix (RM).

Subject: Update on SDG Related Indicators Included in the Provincial
Results Matrix (RM)

1. The Philippine Development Plan (PDP) 2017-2022, geared towards the AmBisyon Natin 2040 and anchored on the 0-10 Socioeconomic Agenda and Sustainable Development Goals (SDG), aims to lay a stronger foundation for inclusive growth, a high trust society, and a globally competitive economy.
2. Since 2017, the DILG and NEDA took various efforts and initiatives in advancing the government's thrust of localizing the PDP 2017-2022 and the SDG. The localization agenda aim to align the development investment programs of the LGUs with the national, regional, and provincial strategic priorities and thrusts embodied in the PDP.
3. The DILG-NEDA Joint Memorandum Circular No. 01, s. 2018 provides the guidelines on the Localization of PDP 2017-2022 Results Matrices and the SDG. Efforts and initiatives on the localization of the PDP-RDP-SDG included the conduct of the following activities in the regional and provincial level: a) localization of PDP 2017-2022, RDP 2017-2022, and SDG including workshop and commitment setting (2018); and b) aligning plans and budgets to provincial results matrix (PRM) committed targets (2019).
4. The DILG MIMAROPA as the overall in-charge in ensuring preparation and submission of localized results matrices by the provinces, regularly monitors the LGU compliance and submission of required forms.
5. The DILG MIMAROPA, during the RDC Special Regional Sub-Committee on the SDG Organizational Meeting held on December 09, 2020, virtually through Zoom, presented the compliance status of the five MIMAROPA provinces with regard to the submission of provincial RM progress monitoring forms to DILG.
6. The DILG MIMAROPA informed the Secretariat through a letter dated May 14, that the DILG is only tasked to monitor the LGU compliance on their submission of provincial RM.
7. The PPDOs of the five MIMAROPA provinces will present their respective update on the SDG related indicators included in the Provincial Results Matrix (RM).

Subject: Core Regional (CoRe) Sustainable Development Goals (SDG) Watch

1. The Philippines, as member of United National General Assembly, adopted Resolution No. 70/1 entitled “Transforming Our World: The 2030 Agenda for Sustainable Development” on September 25, 2015. The said resolution aims to lay down 17 goals of the 2030 Agenda for Sustainable Development in order to engage efforts to eradicate poverty and promote inclusive and sustainable growth for all.
2. PSA Resolution No. 04, s. 2015 enjoins all concerned government instrumentalities to provide necessary data support to monitor the country’s performance vis-à-vis the Sustainable Development Goals (SDG) based on the indicator framework determined by the NEDA, PSA, and other government agencies. The PSA was designated as the official repository of SDG indicators in the Philippines.
3. PSA Resolution No. 09, s. 2017 provides the initial list of SDG indicators, proxy, and supplemental SDG indicators to be monitored in the Philippines. The initial set of SDG indicators consist of 155 indicators; 102 global SDG indicators, 28 proxy indicators and 25 supplemental indicators. Further, the said resolution directs PSA to conduct data assessment of the Philippine SDG indicators at the sub-national level.
4. PSA Resolution No. 12, s. 2019 provides the initial list of core regional SDG indicators (CoRe SDGs) based on the official list of the Philippine SDG indicators for initial monitoring. The initial set of CoRe SDGs consist of 72 indicators (with duplication per goal and target). The PSA, through the Regional Statistical Services Office, shall compile and disseminate the CoRe SDGs at least on an annual basis.
5. The RDC Special Regional Sub-Committee on the Sustainable Development Goals (SDG), during its organizational meeting on December 09, 2020, virtually through Zoom, presented the update on the initial set of CoRe SDGs based on the recent available data (most of available data were in 2018).
6. Among the 65 unique CoRe SDGs, 12 indicators are available only at the national level and 53 indicators are available at the regional level.
7. The PSA MIMAROPA will present update on the CoRe SDG Watch.
