We, from BEN LINE AGENCIES PHILIPPINES INC., appointed as agents for the Indonesia flagged research vessel R/V EGS SURVEYOR (IMO 6820983) and Republic of Marshall Islands flagged R/V GEO RESOLUTION (IMO 8835243) owned by EGS Marine Corporation

The above-mentioned vessels will be utilized to carry out marine route survey covering three (3) point to point segments for the new Proposed Domestic Submarine Fiber Optic Cable Project in Palawan – called Palawan Resiliency under Transport FOC Project Phase 2.

PLDT as the owner has commissioned Wuhan Fiberhome Inc. (Fiberhome) together with its Manila Branch Office. The survey work will be carried out by EGS (Asia) Ltd. as the Survey Contractor appointed by Wuhan Fiberhome Inc. (Fiberhome). The project is expected to run within the Philippines

waters for approximately 1.5 months.

On behalf of EGS (Asia) Ltd., we would like to notify your good office for R/V EGS SURVEYOR and R/V GEO RESOLUTION targeted in shore survey to commenced in 2<sup>nd</sup> week of July while the offshore survey is targeted on mid-July. The survey methodology will only involve Side-Scan Sonar (SSS) at the stern of the vessel within 500m depth area along the planned route. The SSS will be kept at 1/3 of the water column which will have a safe separation from the seabed.


