

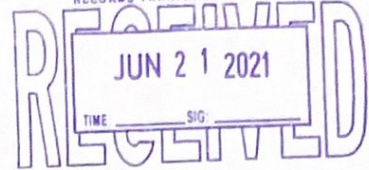

**RESOLUTION REQUESTING HON. ROY A. CIMATU, SECRETARY OF DEPARTMENT OF
ENVIROMENT AND NATURAL RESOURCES, THROUGH ENGR. WILLIAM P. CUNADO,
DIRECTOR OF THE ENVIROMENTAL MANAGEMENT BUREAU, 174 DILIMAN, QUEZON CITY
TO PLEASE FACILITATE THE ISSUANCE OF THE CERTIFICATE IF ANCESTRAL LAND TITLE (CADT)
TO IP'S PERENIALLY OCCUPYING FORESTLAND AREAS BOTH IN THE MAINLAND AND ISLAND
PART OF DUMARAN, PALAWAN.**

**WHEREAS, many IP's in the Municipality of Dumarán, Palawan are occupying forestland areas
but suitable to be classified as alienable and disposable land for residential and agricultural.**

**WHEREAS, these people had long been in their permanent occupancy as evidence by the
perennial trees they have introduced in their respective areas.**

WHEREAS, security of land tenure is their main concern because despite of the long years they been in their permanent occupancy, still they are not yet secured in their respective landholdings.

WHEREAS, pertinent provision of law contained in the RA 8371, otherwise known as the Indigenous People Right Act (IPRA) law provides that these group of people be accorded the right and special privileges granted therein as part of our national and cultural heritage.

WHEREAS, the Municipal IP Federation of Dumarán, Palawan wants to engage the assistance of the agency for the possible resolution of the desired issuance of CALT as hereby requested for our people to be relieved of their anxieties in life.

NOW THEREFORE, in concurrence of all the IPMR members present in the regular meeting of the IP Federation of the Municipality of Dumarán held at Barangay Bohol on May 14, 2021, be it.

RESOLVED as it is hereby to request the HON. ROY CIMATU, Secretary of the Department of Environmental and Natural Resources through Engr. William P. Cunado, Director, Environmental Management Bureau, 174 Diliman, Quezon City to please facilitate the issuance of CALT to IP's perennially occupying forestland areas both in the mainland and island part of Dumarán, Palawan.

RESOLVED FURTHER, the inclusion of this resolution among your priorities for your possible and expeditious action,

RESOLVED FINALLY, that this Hon. Body be furnished a copy of whatever pertinent action you have taken thereon.
