Respectfully referred is the attached letter with enclosures dated June 18, 2021 sent thru email from the Presidential Complaint Center (PCC) bearing **Code No. PCC-CYR-06-10-2021-093** endorsing the email dated May 28, 2021 addressed to President Rodrigo Roa Duterte, transmitted to the Head Executive Assistant and further conveyed to the DENR Action Center/Hotline from **Mr. Karl Louie V. Accordingly, the Barangay Captain of Saraza - Hon. Rommel Mahinay kept refusing to issue such favorable endorsement, instead, other contractors allegedly were allowed to haul aggregates at his quarry site but halted later on when the DENR-MGB personnel intercepted and confiscated said materials.
