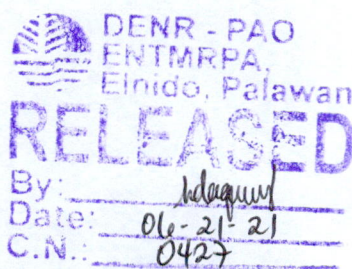


We appreciate your prompt action and for diligently responding on each concerns. Hence, we would like to request for a high resolution copy with clear technical description of the revised map.

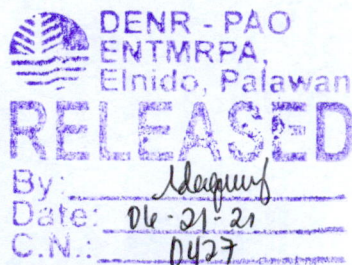
