Isang maka-kalikasang pagbati mula sa Blue finance at Blue Alliance!

Good news! The local government of Puerto Galera has signed already the 10-year co-management of LMMPAs agreement with Blue Alliance for the Or. Mindoro MPA Network, Inc. (Blue Alliance) last May 2021. As part of our governance framework, a separate Stakeholders Advisory Committee (SAC) has been set up for Puerto Galera represented by key stakeholders with DENR as one of its members. In this regard, may we invite you to the first Puerto Galera SAC meeting to be held at the Conference Hall of the Local Government of Puerto Galera on July 2, 2021 at 4:00-5:00 pm. The mandate of the SAC is to provide guidance to Blue Alliance in the planning, management and monitoring of the management of the LMMPAs.

As you may recall, Blue finance, an international non-profit social enterprise that aims to ensure effective management of the Locally-managed Marine Protected Areas (LMMPAs), facilitated the establishment of the Blue Alliance for the Or. Mindoro MPA Network, Inc., a SEC-registered non-profit, non-stock, non-government organization composed of People's Organizations as its founding Board of Trustees: Samasamang Nagkakaisang Pamayanan ng Silonay (SNPS), Calapan; LIKHA, Baco; Kabisig ng mga Mangingisda ng Ilag (KAMI) San Teodoro and and representatives from Blue finance. It also includes the Samahang Pangkabuhayan ng mga Taga Dulangan (SPTD) of Puerto Galera and Kakambal in Brgy. Lazerto, Calapan as members.

Our approach is realized under the supervision of the DENR-BMB and UNDP Philippines. The Protected Areas will restore crucial marine habitats, improve the tourism attractiveness and create significant job opportunities in tourism, fishery and other blue economy sectors. MPAs will also protect the country from coastal erosion and contribute to a more climate-change resilient economy (SDGs n°14, 1, 5, 8 and 13).

The MPAs will receive initial financing from various funding partners such as the Global Fund for Coral Reefs

In time, they are expected to be financially sustainable and generate their own incomes from innovative tourism models, mangrove crab aquaculture, and blue carbon, etc.
