- (2) Still No complete & final implementation of DENR Order DEMOLITION 02 September 2019 thru LGU of Romblon.
- (3) Still No Final CANCELLATION of Approved SURVEY Fli-(DENR-IV)-298-DFLA name of Atty. Francisco F. Benedicto, Jr., despite DENR Order Rejection 20 April 2017, of FLA No. 045910-57 name of same Francisco F. Benedicto, Jr.
- (4) Still No processing by PENRO Romblon ng FLA application ng tatay ko, since 2018 dahil sabi ng Romblon PENRO, kelangan muna i-Cancel ng DENR MIMAROPA R4-B ang Approved Survey Plan issued by DENR, to Atty. Benedicto, Jr.

Maraming pasasalamat po!

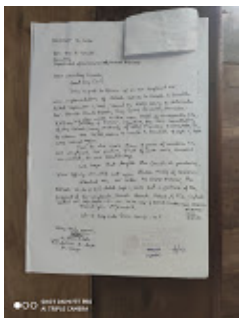

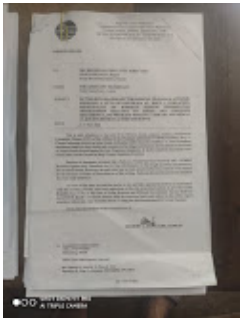
