REQUEST TO MOVE THE CONDUCT OF THE 500 KM TARGET GROUND DELINEATION SURVEY OF PRODUCTION FOREST FOR POTENTIAL INVESTMENT WITHIN THE PROVINCES OF ORIENTAL AND OCCIDENTAL MINDORO FROM

CY 2020 TO CY 2021

This has reference to the ground delineation survey of production forest for potential investment for which 500 kilometers was targeted in the two provinces of the Mindoro Island for CY 2020. For this purpose, Regional Survey Teams were created by virtue of DENR Regional Special Order No. 131, series of 2020 dated February 18, 2020.

The Regional Survey Teams are requesting to move the conduct of the survey from CY 2020 to CY 2021 in view of still active presence of Corona Virus disease 2019 (COVID 19) in both Provinces. Stringent health protocols and safety measures are continuously being implemented by the LGUs in the area, from the Provincial level down to the barangay level which will restrict the teams movement. Further, we have been informed that the Tribal Leaders have limited the entry of lowlanders/entities outside of their tribes to their areas.
