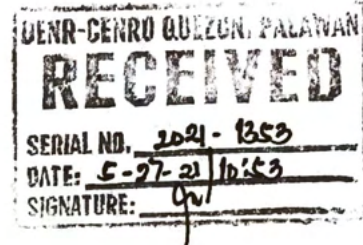

This is to acknowledge receipt of your Memorandum dated March 10, 2021 submitting the Investigation Report of the PENRO Investigation Team created under PENRO Special Order No. 2020-013 regarding the alleged illegal cutting activities within the Joint Venture Area leased by (Joint Venture Area) Lionheart Farms Philippines Corporation, Inc.

Based on ground validation conducted by the investigation team, portions of the subject area were long have been cleared of vegetation. No remnants of new cutting or kaingin activities were found. As to the establishment of azolla pond, the team advised its owner, Mr. Danilo Belaca-ol to reduce its number, and regularly monitor the water passage in his man-made diversion canal for the benefit of the affected farmers.

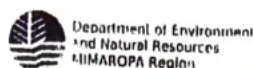
