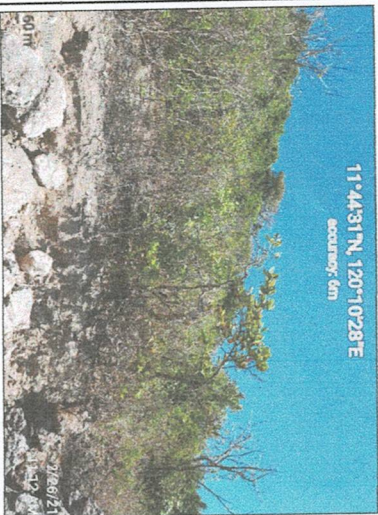
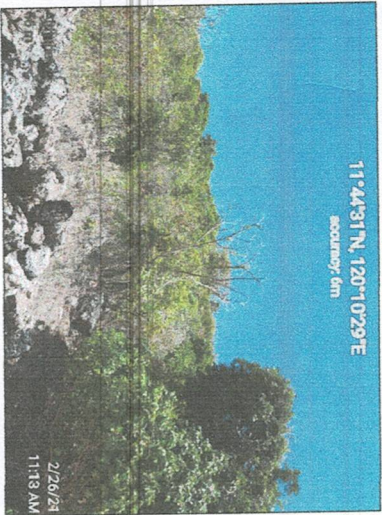

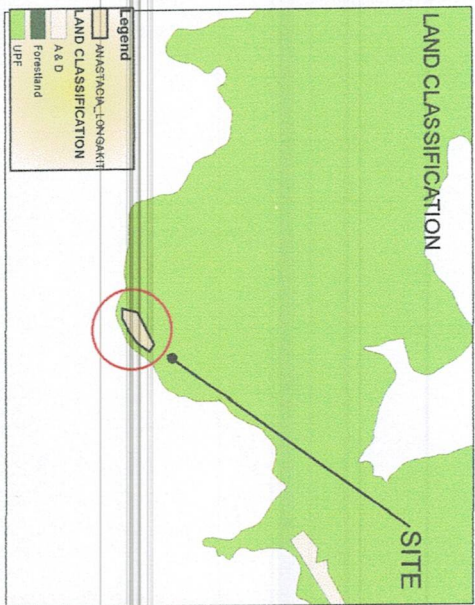

Showing the area covered by

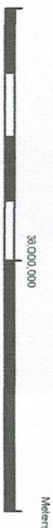
