THAT this CERTIFICATE is hereby awarded to:

Tagumpay, Coron, Palawan to develop and manage a SOCIAL FORESTRY AREA in accordance with the attached AGREEMENT, on a portion of forest land situated in Sitio Leg., Barangay VI, Municipality of Coron, Province of Palawan, containing an area of 2.59 hectares, more or less, bounded and described as follows:





