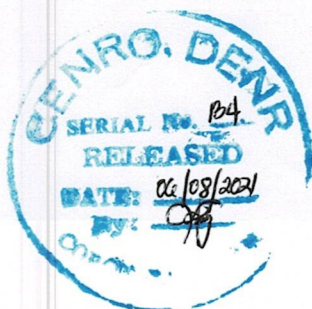

Please be informed that this office had evaluated/assessed a total of Thirty-five (35) CSCs in Barangays of Decabobo, Poblacion 6 and Bulalacao, Coron, Palawan. Out of Thirty-five (35) CSC holders; Seventeen (17) have satisfactory ratings and recommended for renewal; Thirteen (13) are recommended for cancellation of CS Contract for transferring or assigning their allocated land in favor of another person which is strictly prohibited without prior approval of the DENR Secretary per Section 10.9 of DENR Administrative Order No. 4 Series of 1991 while the remaining Five (5) have failed to comply based on the evaluation and findings therefore recommended for issuance of Notice of Neglect.
