SUBJECT : **SPOT REPORT ON THE APPREHENDED ABANDONED IPIL LUMBERS IN BARANGAY STA. MARIA, DUMARAN, PAL.**

Please be informed that on November 5, 2021, the undersigned and Forest Rangers Mark Anthony Ortega, Markwilliams R. Sotoza, James S. Tajon, Alonso A. Tabangay and FPO Efren Esparagoza conducted hauling on the seized lumbers temporary custody in the sub-Office of Dumarán, while the team is heading back to Barangay Itangil, Dumarán, Palawan by chance we spotted and apprehended Ipil lumbers along the Provincial Road in Barangay Sta. Maria, Dumarán, Palawan.

 - a. Violation of section 77 of Presidential Decree 705 as amended by E.O 277 and R.A 7161- **Cutting, gathering and/or collecting timber or other products without license.** Any person who shall cut, gather, collect, or remove timber or other forest products from any forest land, or timber from alienable and disposable public lands, or from private lands, without any authority under a license agreement, lease, license or permit, shall be guilty of qualified theft as defined and punished under Articles 309 and 310 of the Revised Penal Code.

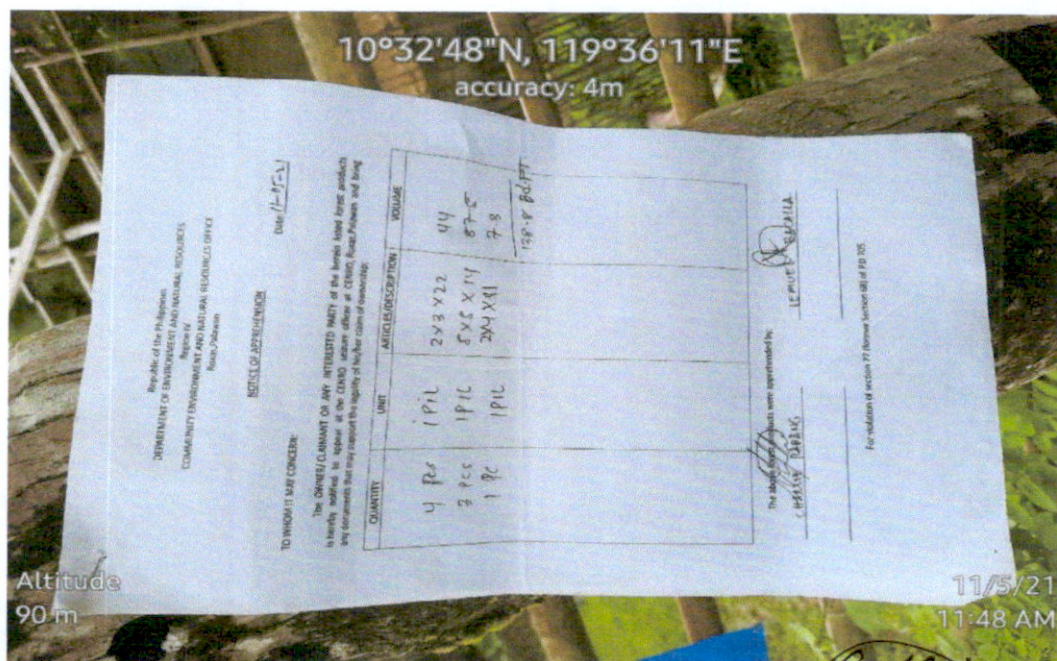
