Respectfully submitting the above subject for your perusal.

On October 28, 2021, the undersigned with the assistance of the Enforcement personnel FT I Voltaire M. Delos Angeles and FR John Vincent Sanchez went on to deliver the letters to the respondents of the complaint of a certain Solomon Rumero logged via dern@8888.gov.ph on October 24, 2021 (Annex 1). The said letters seek the comment/s of the respondents and inform them of the conduct of verification of selected personnel of this Office (Annex 2).

The respondents on the complaint and the allegation/s were:

- Mr Cocjen (father of Ms Donna of DENR Taytay) for allegedly cutting of trees and selling of lumber without permit in Barangays Sibaltan and San Fernando, El Nido, Palawan
- 2. Mr Bong Badilla for allegedly cutting of trees and selling of lumber without permit in Barangay Manlag, El Nido, Palawan
- 3. Mr Dalumpines of Abongan, Taytay, Palawan for transporting of lumber to no permit lumber dealer in Barangay Manlag, El Nido, Palawan





MR EDDIE DALUMPINES

On the same day, the team was able to talk to Mr. Dalumpines. The team informed him of the complaint and ask for his opinion and documents.

He said his business of cutting and transporting of planted trees from Abongan, Taytay, Palawan to El Nido and Puerto Princesa City is legal. He is using the clearance to cut planted trees granted by the Regional Office to Mrs Elva E. Espino represented by him (Annex 3). Before he cuts or delivers, he always requests from the CENR Office for corresponding permits and goes through the proper process.

He said, he used to deliver lumber before to RHDD Trading in Barangay Villa Libertad, El Nido, Palawan. However, he stopped when DENR CENRO-Taytay temporarily stop the operation of RHDD Trading due to some reason. As to the allegation that he delivers lumber to a no permit lumber dealer in Barangay Manlag, he denies the allegation. He mentioned that he has a pending request for transport permit to Barangay Manlag, El Nido, Palawan for Obongon Realty Development along with 75 sacks of charcoal (Annex 4) to be delivered to his daughter's store at So. Bubolongan, Barangay Corong-corong, El Nido, Palawan. He admitted that they are making charcoal out of castoff *acacia mangium* and deliver it at the same time as he deliver lumber. Hence, the complaint against him is baseless.

Mr Dalumpines has gut feeling that Niño Rebiden, owner of Almaster Lumber Dealer was the one behind the complaint against him. He said that Almaster Lumber Dealer ordered to him a 6,000 board feet of lumber which he turned down because Mr Rebiden wanted to get the lumber in credit and instalment basis.







On October 29, 2021, the undersigned proceeded to Mr. Diogracias Cocjen to verify the allegation of Mr Rumero against him.

MR DIOGRACIAS COCJEN

Mr Diogracias Cocjen is no longer active in cutting and transporting of planted trees due to illness. The business he started is now being managed by his daughter Derly Claver Cocjen. As per documents presented by Ms Cocjen, she is using the clearance to cut issued by the Regional Office to Mrs Deldre Jungco of Barangay Bato, Taytay, Palawan (Annex 5) and deliver the lumber to El Nido and Puerto Princesa City.

According to Ms Cocjen, the allegation that his father is cutting and selling lumber without permit to Barangays San Fernando and Sibaltan, El Nido, Palawan is a false accusation. She said, she used to transport lumber to Barangay San Fernando since April to August, 2021 coming from the tree plantation of Mrs Jungco in Barangay Bato, Taytay, Palawan which was granted with clearance to cut. As per copy of transport permits she presented, a total of 5,402.65 Bd.Ft. has been transported to Barangay San Fernando, El Nido, Palawan for Jovane Auman, a resort owner. However, she decided to stop after her last delivery on August due to inadequate supply of lumber. At that time, she is still anticipating for the approval of her request for cutting permit on the tree plantation of Kezia Queen Espia in Barangay Bato, Taytay, Palawan as well as for the tree plantation of Mr Numeriano B. Valledor in Barangay Sibaltan, El Nido, Palawan. Ms Cocjen admitted that they already cut more or less 10 trees from the plantation of Mr Valledor which they used in constructing a light material house to stay on. Other than that all transactions on planted trees were ceased while waiting for the permit to cut.

Ms Cocjen's suspicion on the complainant is the owner of Almaster Lumber Dealer. According to her, Almaster Lumber Dealer ordered to her 6,000 Bd.Ft. of lumber sometime in August but she turn it due to inadequate supply and debt issue and gradual payment on previous deliveries. As well, she is still waiting for the permit to cut.





On November 3, 2021, the undersigned with the assistance of FT I Voltaire M. Delos Angeles carry on to the last respondent on the complaint of Mr Solomon Rumero, Mr Bong Badilla in Barangay Manlag, El Nido, Palawan.

MR BONG BADILLA

The undersigned proceeded at the Barangay Hall of Barangay Manlag to look for a certain Bong Badilla. Mr Jobelson "Bong Badilla. Two (2) Barangay Police accompanied the undersigned to the residence of Mr Jobelson "Bong" Badilla.

According to Mr Badilla he was the authorized representative of his father Lucio Badilla who was granted with clearance to harvest/cut planted trees within his private land in Barangay Aberawan, El Nido, Palawan issued by OIC-CENRO Pablo L. Cruz on December 5, 2018. However, since last year his requests for transport permit were pending. Thus, most of the lumber gradually rotted and he was forced to sell the good ones to make up for the cost and to sustain their daily needs.

Mr Badilla's assumption, it is the owner of Almaster Lumber Dealer who complained against him. He said, he used to deliver lumber to Almaster before. However, due to his pending requests to DENR Office, he can no longer deliver to the said lumber dealer. And according to him, even though he still has lumber and issued with transport permit, he will no longer deliver to Almaster due to debt and gradual payments that caused losses on his part.

The undersigned verified on records that Mr Badilla was stopped by the Office to transporting lumber through letter dated August 20, 2020 (Annex 6) citing the Memorandum of Regional Executive Director Henry A. Adornado dated February 14, 2019 clarifying that the cutting of planted trees within private lands shall be allowed subject to the clearance to be issued the Regional Executive Director. Hence, Mr Badilla was advised to secure the necessary clearance.





DISCUSSION AND RECOMMENDATION

In view of the opinion of the three (3) respondents on the complaint of a certain Solomon Rumero, it appears that they have common suspicion on the complainant. They were all believed that it was the owner of Almaster Lumber Dealer. All of them used to deliver lumber to Almaster previously but decided to turn down recent orders in almost the same reason.

Almaster Lumber Dealer is the only authorized lumber dealer in El Nido, Palawan at present. According to the opinion of the respondents, only the Almaster Lumber Dealer who has the courage to complain against them because he can no longer get a supply of lumber from them.

The undersigned also exhaust to locate the complainant Solomon Rumero. Considering that his complaints were related to planted trees, the undersigned assumed that he is connected to similar business. Per records verification, there was one Rumero/Romero connected to transporting planted tree lumber within the jurisdiction of CENRO Taytay. It is Maribel

Romero of Abongan, Taytay, Palawan but she is no longer active since her clearance to cut was put on hold in 2020 for same reason as of Mr Badilla. The undersigned inquired though phone to Barangay Abongan if there is a residence named Solomon Rumero in their barangay and it turns out negative. But accordingly, there are also Rumero residing in Barang New Guinlo, Taytay, Palawan. The undersigned also inquired to Barangay Chairman Zaldy Escasinas if he has a resident in his barangay named Solomon Rumero and he confirmed that there is one Solomon Rumero residing at Sitio Carlet. The team went to New Guinlo after Office of October 27, 2021 to meet Solomon Rumero at the residence of the Barangay Captain Escasinas. We are able able to talked to Mr Rumero past 9'oclock in the evening after he came from fishing. Mr Rumero is a fisherfolk of New Guinlo who has no knowledge about planted trees. Proof to this is the certification issued by Brgy. Captain Escasinas (Annex 7). The undersigned asked Mr Rumero if he has any acquaintances or relatives connected to planted tree business but according to him none.

Further, the undersigned found out from Brgy. Captain Escasinas that Niño Rebiden who owns a lumber store in El Nido, Chuannie Rebiden Cadelenia who transport planted tree lumber from Roxas, Palawan and Joan Rebiden Otic who is also a lumber dealer in Taytay, Palawan are former residents of So. Carlet.




Based on the opinion of the respondents and the findings of the undersigned, it appears that the name of Solomon Romero has been used as complainant. It is most likely that the real complainant is also an acquaintance of the respondents and related as well to planted tree business who cannot get supply of lumber from them or an envious competitor because more planted tree lumber users were directly orders supply of lumber from Mr Dalumpines and Ms Cocjen.


