Pursuant to Republic Act No. 9418 (the Volunteer Act of 2007) and Executive Order No. 635, the MSAB was created to assist the PNVSCA in the policy review and formulation, and strengthening linkages between and among volunteer groups. The MSAB includes among its members PSRs who shall serve for a two-year term; this may be extended for another term but not to exceed four years.

In this regard, we would like to extend to you this call for distribution to your volunteer networks. The nomination for the PSRs to MSAB is open to all bonafide Filipino organizations that are SEC-registered and preferably accredited by a government agency, with nationwide geographic and network.

The submission of nominations has been extended until **December 31, 2021**, at **5:00 PM**.
