

Workshop on the Development of the DILG-DOT-DENR Joint Operational Structure on Local Ecotourism Management

BACKGROUND

The success of the Boracay Island Rehabilitation in 2018 became the impetus for the directive to the Departments of the Interior and Local Government (DILG), Environment and Natural Resources (DENR), and Tourism (DOT) to continuously monitor and be vigilant in the supervision of all other island resorts as enshrined in Cabinet Action File No. 535-091118-15-16-17.

As a response, the three agencies proceeded to implement their respective programs, projects, and activities in prime ecotourism sites pursuant to their respective mandates. However, several challenges have been encountered by the agencies in the implementation of their respective programs, projects, and activities within the ecotourism sites. These included the following:

- Overlapping frameworks and plans on ecotourism management among agencies;
- Redundancies in the inspections;
- Lack of a harmonized standard process flow in obtaining permits, licenses, and accreditations from DOT/DENR/BPLO;
- Lack of a Locally Unified data bank system accessible to all concerned agencies;
- Lack of Manpower/Designated Personnel including the lack of permanent Tourism Officers to continue and implement tourism related regulations and DOT programs;
- Lack of a common platform to discuss cross-cutting issues and complaints; and
- Lacking capacity of DENR and DOT to strengthen coordination with LGUs.

Further, the DILG, through the BTMT-PMO, conducted a Virtual Forum on Emerging LGU Roles on Tourism Management in the New Normal on 18 May 2021. The recommendations were the following:

- Harmonization of policies of different agencies engaged in tourism through strengthening institutional partnerships and ensuring the functionality of mechanisms for policy implementations;
- Strengthen capacities of local official on new innovations in tourism and how they will effectively respond to the pandemic crisis; and
- Strict enforcement of policies in close coordination with relevant agencies

On 21 July 2021, the DILG, DOT, and DENR conducted a joint meeting to update the current initiatives of each Department with regard to the Presidential directive on the supervision and monitoring of the priority ecotourism sites. It also intended to discuss the potential of adopting a joint operational structure among DILG, DENR, and DOT, to harmonize the Departments' initiatives similar to the Boracay Island rehabilitation efforts. Given the identified challenges, the three agencies agreed to adopt a joint operational structure through an issuance of a Joint Administrative Order or Joint Memorandum Circular.

- 3. Create component functional mechanisms that will provide support and guidance to JOS implementation.


In preparation for the said activity, our team has prepared this information sheet to ensure the quality and substantial flow of the program.
