This request was reiterated in the 09 November 2021 Memorandum to the DENR – MIMAROPA Region.

Please be assured that, if necessary, this Office shall act further after the DENR – MIMAROPA Region has ruled on the validity of the issue.

Attached are copies of the Letters dated 26 August 2021 and 27 August 2021 of Mr. Antonio Baguinsa and Engr. Cynthia E. Rosero, Resident Mine Manager of Rio Tuba Nickel Mining Corporation (RTNMC), respectively, regarding the alleged encroachment of the mining operations of RTNMC under Mineral Production Sharing Agreement No. 213-2005-IVB to the private land of Mr. Baguinsa.

Based on our evaluation, this Office finds that the issue is more of a land title conflict which is beyond our jurisdiction. Please note that per above-cited letter of RTNMC, it claimed that Engr. Jonathan Gellez of PENRO "xxx did not complete the verification of the two remaining monuments on the property subject of the survey," and that such casts doubts as to the accuracy, completeness and truthfulness of the data in the survey report.

In this regard, we are respectfully requesting that the issue raised be resolved by your Office. This Office shall act further only if your Office has ruled on the validity of the survey and the possible encroachment from the mining operations of RTNMC.

This refers to your letters dated 26 August 2021, 02 August 2021 and 22 July 2021 claiming that there is an encroachment in your titled properties situated at Brgy. Sandoval, Bataraza, Palawan by the mining operations of Rio Tuba Nickel Mining Corporation (RTNMC) under its Mineral Production Sharing Agreement No. 213-2005-IVB.

We have written RTNMC by providing them a copy of your letter dated 22 July 2021 for their comments/reply. RTNMC has responded thru their letter dated 27 August 2021, which was received by this Office on 02 September 2021. A copy of the response-letter is attached for your guidance and information.

Upon evaluation of the allegations of both parties, this Office finds that the issue is more of a land title conflict which is beyond our jurisdiction. This Office has forwarded the issue to the Department of Environment and Natural Resources (DENR) – MIMAROPA Region for its resolution. If the DENR – MIMAROPA Region resolves the issue of the validity of the survey of Engr. Jonathan Gellez and that there is a possible encroachment from the mining operations of RTNMC, then this Office shall take further action. A copy of the Memorandum is attached for your reference.
