Relative to our Memorandum of 21 September 2021 requesting the submission of proposals for funding under the IPAF-SAGF for FY 2022 and based on the previous proposals which were not accommodated this FY 2021, we are pleased to inform you that the following candidate protected areas for funding with corresponding budget allocations can access the IPAF-SAGF (25% Central Fund) for FY 2022, subject to submission of complete requirements:

Consistent with the BMB Technical Bulletin No. 2021-03 (Guidelines on the use of Protected Area-Retained Income Account (PA-RIA) and Special Account in the General Fund (SAGF), and Protected Area Trust Receipts (PA-TR) and providing the criteria for the allocation of funds deposited under the IPAF-SAGF in the National Treasury), please submit your updated Work and Financial Plans for FY 2022 depicting the proposed programs, projects and activities of each PAMOs **on or before 30 November 2021**. Given our circumstances due to the pandemic and to facilitate our review and evaluation of your proposals, you may submit advance copies of the WFPs through npd@bmb.gov.ph.

Complete supporting documents shall be submitted upon our advice based on the Bureau's evaluation of the submitted WFPs. For the meantime, you may already prepare the following documents:

1. BTr Certification (for 75% Old Subfund Prior to RA 10629)
2. MDS Account Number Certified by the Bank
3. Statement of Receipts and Utilization
4. For proposals that involve purchase of motor vehicles/water crafts:
 - a. Specifications/Description/Classification/Unit Cost and Deployment per Budget Circular No. 2017-1
 - b. Justification for the purchase of such vehicles
 - c. Inventory of existing motor vehicles (PENRO)
 - d. Canvass (3)
5. For proposals that involve purchase of equipment:
 - a. Inventory of existing office equipment (PENRO)
 - b. Project Procurement Management Plan
6. For proposals that involve establishment of facilities/infrastructure:
 - a. MGB Certification that the location, sites are not included in the critical geo-hazard areas or no build zones identified
 - b. Specification of the building to be determined by DPWH
