The Department of Environment and Natural Resources (DENR) through the Strategic Communication and Initiatives Service (SCIS) in partnership with the National Bicycle Organization (NBO) enjoins the nation in celebrating the Clean Air Month this November by holding the 7<sup>th</sup> National Bicycle Day on 28 November 2021 at the Centennial Park, Brgy. Bagumbayan North (BBN), Navotas City.

The 7<sup>th</sup> National Bicycle Day, a 26-km bike parade, will pass through the cities of Quezon, Manila and Navotas. The theme for this year's celebration, "Cleaner Air through a Bicycle-Friendly Philippines", It aims on improving the quality of air in Metro Manila through a non- motorized mode of transportation while fostering sustainable development and promoting environmental health.
