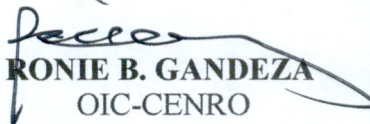
Greetings!

Information alleging that your men are conducting land surveys and fencing at Sitio Landing in Bgy. Poblacion, San Vicente, Palawan consequently blocking portions residents use as access roads, was brought to the attention of this Office. As public land surveys yet remain suspended in the locality and it appearing that initial findings affirm fenceings reported as evidenced by geo-photos taken on site, please be requested to present proof, if any, to the effect that the lands referred to in the complaint have otherwise become your private properties.

On the *otherhand* kindly be advised to refrain from resorting to such acts as are currently not allowed in the *area* and cause reopening of affected road-right-of-ways especially considering that such are civil concerns the LGUs are mandated to provide its constituents.

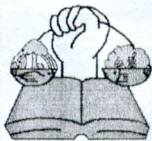

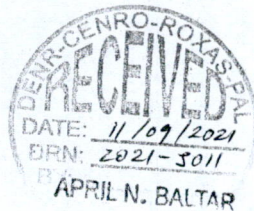

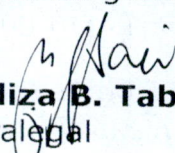
Isang maka-kalikasang pagbati!

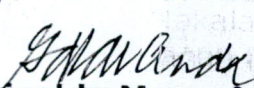
