An individual report using the prescribed format shall be submitted by each participant within fifteen (15) days after the event to the undersigned thru the Assistant Regional Director for Management Services.

On the other hand, failure of a participant to attend the said activity without an advance written explanation shall be considered a light offense, pursuant to *Rule 10*. *Section 50 (f) (3) of the 2017 Rules on Administrative Cases in the Civil Service (RACCS)*, and a notice of Charge shall be issued by the Regional Executive Director.

PENRO Marinduque GADFPS shall submit a report within fifteen (15) days after the completion of the activity to the undersigned thru the Assistant Regional Director for Management Services.

This Order takes effect on the aforementioned dates.
