Dear Engr. Legaspi:

We are writing your office on behalf of our principal, Mr. Gerard Singson.

On 16 June 2021, the CENRO Roxas of DENR Region IV-MIMAROPA issued a Certification that Lot 1118-C with 29,303 square meters in Brgy. Poblacion, San Vicente, Palawan is within the forest land falling inside Block JJ of Land Classification Project Numbered 1-T which was approved on 01 July 1966 as LC Map No. 2598 (Annex "A").

Our principal bought this property sometime in November 2008 from a certain Rico Tabangay, married to Thelma Tabangay. During the acquisition, our client was provided with a Certification from DENR CENRO Roxas that Lot 1118 with a total area of 221,525 square meters falls within alienable and disposable under Project No. 1-B, Block 11 per LC Map 2880 certified on 13 October 1981 (Annex "B"). This document was signed by them OIC, CENRO Wilfredo R. Angeles.

He was also provided with a Subdivision Plan of Lot 1118 prepared by Engr. Ramon Rubio on 25 August 2007 signed by then Chief LMS Florante A. Candido (Annex "C"). In the same document, Notes mentioned the following:

- This survey is inside alienable and disposable areas per Proj. No. 1-B, LC Map No. 2880 and released on 13 October 1981 as per investigation report dated 25 April 2007 of LMO Florante A. Candido of CENRO Roxas, Palawan.
- Lots 1118-A, 1118-D, 1118-J, 1118-M and 1118-N falls within the timberland.
- As per "MEMORANDUM" (Supplementary Report) dated 19 June 2008, issued by LMO Florante A. Candido – The projection of the Forest Management Service of the Regional Office show that a portion on the southern tip of Lot 1118 falls within the sea, and there is no such thing observed during the conduct of survey, the lot as surveyed is being whole and intact.

Finally, we secured a copy of LC Map 2598 from NAMRIA and we noticed in the notation that Block JJ did not mention any timberland in the area (Annex "D")

Currently, our principal is the registered owner of Lot 1118-C under Katibayan ng Orihinal na Titulo P-14523 issued on 15 September 2009 under Homestead Patent No. 045319-09-3976 (Annex "E").

Inasmuch as the CENRO Certification issued on 16 June 2021 is 'subject to confirmation by the DENR-MIMAROPA Regional Office, we would like to request for the assistance of your office to correct the Certification issued by DENR CENRO Roxas dated 16 June 2021.

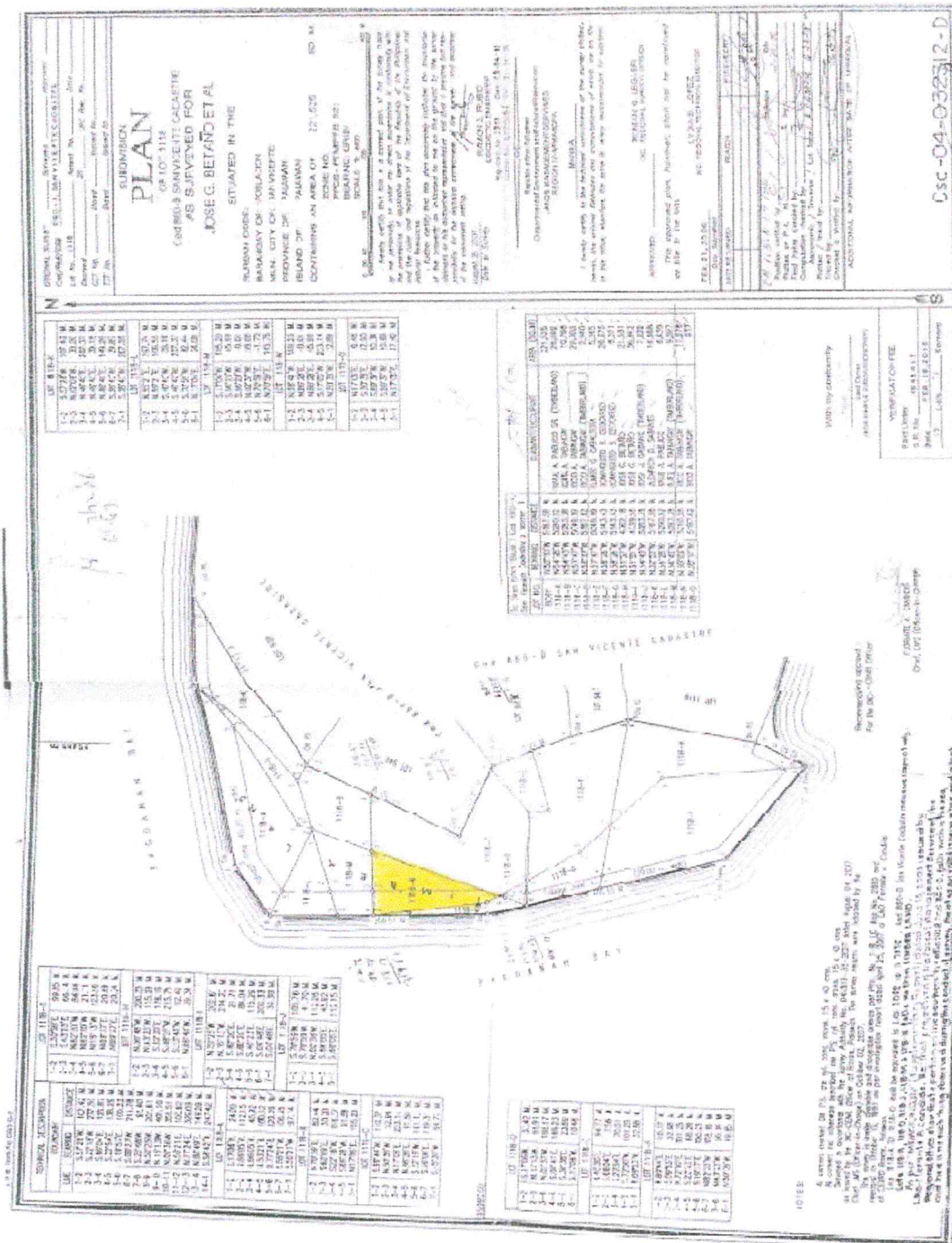
