Dear Mr. Nepomuceno:

This is to acknowledge receipt of your email reply dated November 4, 2021, following up on your concerns on the adoption of the earth-balling method being done in Japan and suggestion to adopt a procurement program for the machinery to be used by the Department of Environment and Natural Resources (DENR), Department of Public Works and Highways (DPWH), and the Local Government Unit (LGU).

Please be informed that the procurement program has already been established while strictly observing the provisions stated in Republic Act (R.A) No. 9184, or the *Government Procurement Reform Act* and its 2016 Revised Implementing Rules and Regulations dated March 31, 2021. The governing principles on government procurement are reflected in the transparency and streamlining of the procurement process, competitiveness on extending equal opportunities to participating parties, a system of accountability of public offices involved in the process, and public monitoring of the awarding of contracts in view of guaranteeing that all contracts are performed strictly according to specifications.

As regards your additional concern on the Mahogany trees felled in the diversion road of Boac and Mogpog, please be advised that all logs derived from national government priority projects such as the DPWH, pursuant to DAO No. 2018-16 dated July 18, 2018, or the *Guidelines in the Processing and Issuance of Permits on the Removal and Relocation of Trees affected by DPWH Projects*, and DAO No. 2020-06 dated February 12, 2020, or *Amending Certain Provisions and Expanding the Coverage of DAO No. 2018-16*, are being turned over in the DENR field office, for proper disposition.

You may coordinate with the nearest DENR field office in your area should you have further concerns on the matter.
