In reference to the agreements / ways forward during the RTF COVID-19 MIMAROPA Meeting (VTC) on 25 November 2021 via Zoom Application, this is to respectfully inform you of the items discussed and the required actions from the respective agencies/offices:

<ul style="list-style-type: none"><li>Provide the RTF COVID-19 MIMAROPA with the report/list of LGUs who are performing below the expeditious manner in the COVID-19 vaccination program, with consideration to the said LGUs' capacities and the threshold/indicators for the targets (in coordination with DOH MIMAROPA)</li></ul>	DILG MIMAROPA
<ul style="list-style-type: none"><li>Provide the RTF COVID-19 MIMAROPA the data of the social profile/sector of the source of COVID-19 positivity rate</li><li>Identify and provide DOE USEC Alexander Lopez with the list of vaccination sites in Geographically Isolated and Depressed Areas (GIDA) with Power Interruptions / Power Supply issues</li><li>Recommend to the NVOC to refrain from providing the LGUs with Pfizer COVID-19 vaccines, to avoid deterioration of the efficacy due to insufficient cold storage facilities. Further, the preference of the region on the appropriate COVID-19 vaccine brand may also be recommended to the NVOC</li><li>Coordinate with the PNP MIMAROPA Operations Center, through PBGEN Celso L. Bael, on the utilization of PNP MIMAROPA OPCEN Radio Communications Network effective today 25 November 2021, until 23 December 2021 for <i>Bayanihan, Bakunahan</i></li><li>Assign PDOHO Oriental Mindoro personnel to render duty in PNP MIMAROPA Radio Operations Center. They shall perform as the main link of MIMAROPA RVOC to the different LVOCs and LGUs through the radio network of PNP MIMAROPA.</li></ul>	DOH MIMAROPA

<ul style="list-style-type: none"> <li>• Invite the National Commission on Indigenous People (NCIP) to future RTF COVID-19 Meetings, to provide information on the assistance required, actions taken, services provided, and status of COVID-19 infection (if any) in indigenous people communities</li> <li>• Activate the Virtual EOC of the RTF COVID-19 MIMAROPA (to include PRO MIMAROPA, WESCOM, SOLCOM, DOH MIMAROPA, DILG MIMAROPA, PCG, BFP MIMAROPA, DICT LC3 and PLTGs of MIMAROPA), in coordination with the Regional and Local Vaccination Operations Centers of MIMAROPA</li> <li>• RTF Virtual EOC located in OCD MIMAROPA to submit <i>Bayanihan, Bakunahan</i> Daily Reports to USEC Alexander Lopez effective tomorrow 26 November 2021, until 23 December 2021</li> <li>• Coordinate with OCD CALABARZON to ensure prior coordination is undertaken for the smooth access of COVID-19 essential response resources / personnel in the port areas going to and from MIMAROPA Provinces</li> </ul>	OCD MIMAROPA

<ul style="list-style-type: none"> <li>• Submit to OCD MIMAROPA the official report on the refusal of PPA Batangas Security Personnel from allowing the official vehicle, which will transport specimen to testing facilities, from entering the Batangas City Port, for the appropriate action of the relevant agency</li> </ul>	PDRRMO Romblon
