Thank you for your email.

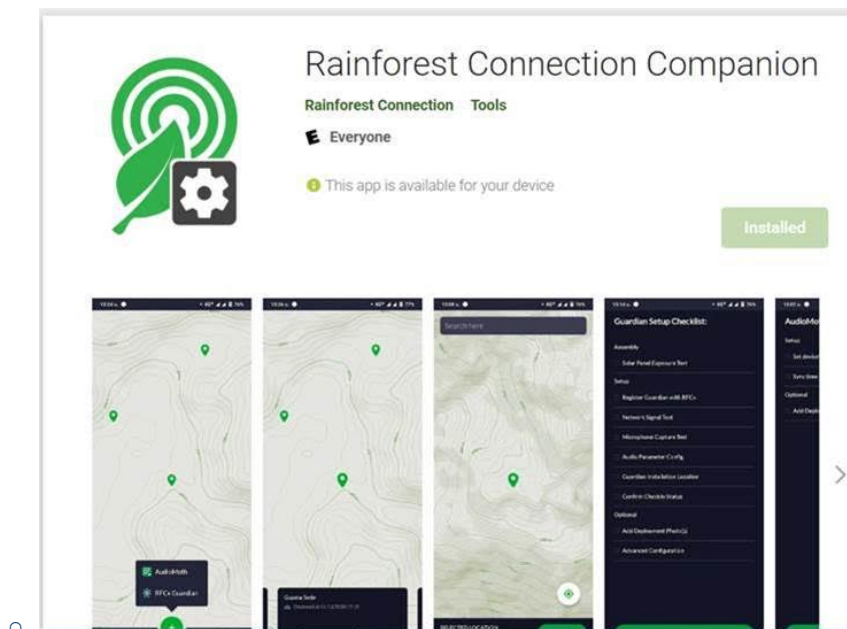
