This refers to the Coron-Culion Inter-island Bridges Project (CCIBP) of DPWH. It has a total project cost of Php 4.29 billion, with initial funding of Php 250 million under the FY 2020 General Appropriations Act. It involves the construction of four new roads with an aggregate length of 17.54 kilometers (km) and three bridges with length of 2.63 km to interconnect Coron via Lusong Island with Marily Island in Culion.






