Greetings!


Referring to your protest appearing filed involving respective portion of Lots 4294 and 4295 of Cad. 860-D in Bgy. Kemdeng, San Vicente, Palawan and recently being followed up, records affirm your information that Lot 4295 was already acquired by Guillermo Abique. Lot 4294 on the other hand appears covered not by any application by the Heirs of Guillermo Abique but by FLA 045319-148 and PPA 045319-04 of the Heirs of Rosario Cameña represented by Marita Cameña.

As this Office exercises no jurisdiction over lands already registered save on issues of reversion and owing to the fact that only objections against applications duly filed are sanctioned by the Public land Act (CA No. 141) as amended specifically pursuant to Section 102 thereof, this Office cannot help but refer your concerns over part of Lot 4295 to a court of competent jurisdiction and advise that you see the Office for evaluation of claims you have over part of Lot 4294, especially considering that leases and permits are not among those suspended of public land activities in the province.

Foregoing considered, your supposed protest had to be, as hereby the same is, set aside.
