On 28 July 2020, our office received a copy of the Memorandum from the Regional Executive Director concerning the result of the RTK survey conduct, instructing your good office to deploy a team to conduct delineation of 20- and 40-

meters easement under P.D. 1067 on the stretch of the beach and issue Notice to Vacate (NTV) to owners of structures found within the easement zone.
