Sir,

The Office of Building Official of LGU-EI Nido has difficulty in implementing the RA 11032 also Known as "Ease of Doing Business and Efficient Government Service Delivery Act of 2018" guidelines due to the DENR, DILG & Tourism letter to the Municipality of EI Nido dated August 2019 declaring a Moratorium on the issuance of all permits for the construction of all new buildings and any improvement on existing structure until the study on carrying capacity of EI nido is completed.

Building Owners and Investors in EI Nido are willing to comply with the requirements and regulation on building structures and the environmental laws.

However, more than two (2) years have passed but until now the said moratorium is not yet lifted thereby, obliging some investors to start their construction activities without first securing a building permit. from the office of the Building Official.

It was learned from some reliable sources that the study on carrying capacity of EI Nido has been done months ago, but up to now the municipality of EI nido have not received any letter or order from the DENR / DILG and Tourism lifting the said moratorium.
