

As per memorandum dated June 16, 2021 of the OIC, PENR Office Mamburao Occidental Mindoro regarding the above noted subject.

On June 2018, the investigation report Entitled “INVESTIGATION REPORT ON THE PROTEST OF MRS. ELSA D. ZAMORA ON LOT 1554, PLS-15 LOCATED AT IRIRON, CALINTAAN, OCCIDENTAL MINDORO” was already submitted to the Regional Office-MIMAROPA for proper Resolution of the case. Unfortunately, the lot occupied by the complainant is included on this investigation.

On October 15, 2019, the Regional Office facilitated an Alternative Dispute Resolution to amicably settle the disputes of the said case and successfully settled with the condition that each of the siblings (Elsa D. Zamora, Minerva D. Bulan, Ramon Delos Santos, and Isidro Santos) shall have a share of 3.7 hectares each, however, the bearings of the partition was not included on the agreement. This Amicable Settlement Agreement were already signed and agreed by all of the parties.

The undersigned tried to settle the bearings of partition among them to finally settle the issue and they have come up to an agreement however, when I’m going to identify the boundaries in order to have a basis to divide their properties, one certain Mr. Isidro Santos changed his mind, revoked the agreement before it was signed and agreed that the case be brought to the Public Attorneys Office.

On December 17, 2020, Mrs. Elsa D. Zamora, Ramon Delos Santos, and Joemel Bulan, submitted to this office a Sinumpaang Salaysay that:

1. On January 28, 2021, this Office recommended that the agreement was facilitated by the Regional Office and the Investigation Report of the case was already forwarded to the Regional Office, therefore it was recommended to prepare a communication and endorse their request to the Regional Office Legal Division for approval.

On April 8, 2021, the request of Mrs. Elsa D. Zamora, Mr. Ramon Delos Santos, and Mr. Joemel Bulan to revoke the Alternative Dispute Resolution Agreement facilitated by the Regional Office MIMAROPA has been forwarded to the Regional Office as per recommendation.

Base on the above noted facts, this issue needs approval of the cancellation of the Alternative Dispute Resolution Agreement, since that the Regional Office is the one who facilitated the ADR proceedings. I, therefore recommends to prepare a follow up communication that this case needs approval of cancellation of ADR Agreement to the Regional Office.
