We are submitting herewith the Project Status Report (PSR) of the Special Project entitled, "Research on the Meta-population of Tamaraw in Mindoro" as of September 2021.

The Project aims to establish information on the island-wide habitats, distribution and estimated populations of Tamaraws in Mindoro and to develop alternative counting methodology/ies to estimate Tamaraw population suitable to a range of habitat types developed. The implementing units are the DENR-PENRO Occidental Mindoro and DENR- IV-B (MIMAROPA) Regional Office. At the end of the Project, the expected outputs are: a) Island-wide spatial map of Tarnaraw distribution and habitats in Mindoro established; b) Tamaraw population in the Island of Mindoro estimated; and c) Appropriate methodology/ies for Tamaraw population count suitable to a range of habitat types developed.

The Project was approved for implementation by the Secretary on December 2, 2020 for special funding under DENR II.d. Conduct of Special Studies, Design and Development in Support of Biodiversity, Forestry, Mining and Environmental Management Operations. Description:

The Tamaraw, a critically endangered mammal found only in the island of Mindoro and the proposed National Land Mammal, continues to face challenges and threats that contribute to its general population decline over the last century. The Tamaraw Conservation and Management Action Plan (TCMAP) is the result of Population Habitat and Viability Assessment Workshop conducted in December 2018 by the DENR Tamaraw Conservation Program, funded by BMB-Biodiversity Finance Initiative (BIOFIN) and facilitated by BMB-Biodiversity Finance Conservation of Nature (IUCN) Asian Wild Cattle Specialist Group and Conservation Planning Specialist Group.

The Population Habitat and Viability Assessment (PHVA) workshop in 2018 has identified many issues and concerns that lead to the crafting of the IO-year TCMAP. This proposal aims to answer some primary issues and concerns on meta-population component.

Per TCMAP, there are many gaps on the knowledge of the population dynamics of the Tamaraw. This issue is caused by information gaps on the possible locations and habitat range of Tamaraws across Mindoro. As a result, the remaining population of the Tamaraw cannot be estimated for the whole island of Mindoro but limited only to its core habitat within Mts. Iglit-Baco Natural Park (MIBNP). Furthermore, the only method of counting being used since year 2000 within 2,200 hectares Tamaraw core habitat in MIBNP is the Intensive Concentration Count (ICC) or Simultaneous Multi-vantage Point Count (SMVPC) where "controlled burning" is the preparatory activity to conduct the ICC/SMPVC to improve visibility of Tamaraw and enhance sprouts of cogon and talahib grasses which are main forage for said animal. With this method, there are major

disadvantages like burning risks other forms of life, reduces fertility of the soil, hamper diversity and prevent forest succession. Finally, ICC/MPV is suitable only in a grassland ecosystem while Tamaraws have been recorded in scrublands and forest ecosystems.

In order to address the aforesaid issues, this project covers two (2) major parts:

- a) Island-wide dentification and mapping of the Tamaraw locations and habitats; and
- b) Meta-population monitoring **thru** identification of appropriate count methods suitable to a range of habitat type.

Mindoro Island (provinces of Occidental and Oriental Mindoro) covering twenty-two (22) municipalities. The 22 municipalities were identified based on land classification map and actual land cover per **Google** earth view. The target sites also include unexplored areas (outside of Tamaraw core habitat) of Mts. **Iglit-Baco** natural Park, and other known habitats of Tamaraw.

Objective:

Specifically, the Project aims to:

- 1. Establish information on the island-wide habitats, distribution and estimated populations of Tamaraws in Mindoro; and
- 2. Develop alternative counting **methodology/ies** to estimate Tamaraw population suitable to a range of habitat types developed.

- 1. Island-wide spatial map of Tamaraw distribution and habitats in Mindoro established
- 2. Tamaraw population in the Island of Mindoro estimated
- 3. Appropriate **methodology/ies** for Tamaraw population count suitable to a range of habitat types developed
