CHIEF, CONSERVATION AND DEVELOPMENT DIVISION TO THE NATIONAL NIPAS REVIEW COMMITTEE-TECHNICAL WORKING GROUP MEETING ON OCTOBER

20, 2021

This is in reference to the proposed proclamation of Calsanag Watershed Forest Reserve (CWFR) and Naujan Lake National Park, as protected area under the NIPAS. It may be recalled that the supporting documents for these protected areas were already discussed during the NNRC Meeting held on April 19, 2021 and was advised by the Committee to table this for further discussion by the Technical Working Group, once created. Relative thereto, may we request the participation of the following concerned regional and field office staff to attend the National NIPAS Review Committee-Technical Working Group (NNRC-TWG) Meeting on October 20, 2021 at 9:00 AM via Zoom:

- 1. Chief, Conservation and Development Division, DENR MIMAROPA Region;
- 2. Protected Area Superintendent, Calsanag Watershed Forest Reserve; and
- 3. Protected Area Superintendent, Naujan Lake National Park

May we also request the Protected Area Superintendent to prepare a presentation for their respective protected areas to include geospatial information, showing maps like Land Classification map, physical and sectoral boundaries such as agricultural, forestland, mineral and other legal classification. The presentation should also include identification of tenured migrants and other area occupants, titled areas, and existing tenurial instruments, in the area. Also, pictures of the site outstanding features/characteristics and the results of the Regional NIPAS Review Committee Meeting should be included.
