# **BACKGROUND INFORMATION:**

Through an e-mail dated 15 September 2021, the DENR Action Center referred for immediate attention the attached Letter from the Presidential Complaint Center bearing PCC Code No. .GL-CYR-08-25-2021-043 forwarding the Letter-Complaint dated 09 August 2021 from a certain Mario Ramirez of San Jose, Occidental Mindoro addressed to President Rodrigo Roa Duterte (Please see Annexes 1 to 3.).

In the said Letter, the abovementioned complainant accused the OIC, PENRO and Concurrent Designated Chairperson of the PMRB of Occidental Mindoro of alleged selective acceptance of quarry permit applications and allowing sand and gravel operations within one kilometer-distance from the boundaries of public or private structures in the rivers of Occidental Mindoro.

Hence, the undersigned, were dispatched to the municipalities of Mamburao and San Jose, Occidental Mindoro on September 27-30, 2021 to conduct the necessary field investigation pursuant to Travel Order Nos. 390 & 391 dated 23 September 2021 and 87 & 88 dated 04 March 2021. Field proceedings consisted of data gathering and interviews with the concerned parties.

# FIELD FINDINGS:

1. During an interview with PENRO Ernesto E. Tañada, OIC, PENRO and Concurrent Designated Chairperson of the PMRB of Occidental Mindoro, he vehemently denied the aforementioned allegations. He emphasized that he is fully aware of the provision under Section 79a of DENR Administrative Order (DAO) No. 2010-21 which provides that:

"No extraction, removal and/or disposition of materials shall be allowed within a distance of one (1) kilometer from the boundaries of reservoirs established for public water supply, archaeological and historical sites or of any public or private works or structures, unless the prior clearance of the Government agency(ies) concerned or owner is obtained."

- 2. PENRO Tañada informed that he has been imposing the provision of Section 79a of DAO No. 2010-21 ever since he was designated as PMRB Chairperson as per RSO Nos. 2019-014 and 2021-047 (Annex 4).
- 3. PENRO Tañada further stressed that he does not accept mining applications inasmuch as being the Designated Chairperson of the PMRB, his job is to primarily to preside over meetings of the Board and conduct deliberation of mining applications pursuant to the RSO issued.
- 4. It was learned that a similar complaint were lodged against the ENRO of Occidental Mindoro to the DILG (Annex 5) which was then forwarded for appropriate action to the Office of the Governor of Occidental Mindoro (Annex 6).

- 5. The ENRO likewise denied the allegations of Mr. Ramirez, furnishing the undersigned with a copy of his Letter dated 07 September 2021 (to Governor Eduardo B. Gadiano, Provincial Governor of Occidental Mindoro Annex 7).
- 6. In the said ENRO's Letter, he informed, among others, that the permit granted within the one kilometer-radius, is supported by a clearance from the DPWH in accordance with Department Order No. 2014-139 and is duly signed by the District Engineer. (Please refer to Annexes 8 and 10). Furthermore, he conveyed that the ENRO is not authorized to issue a permit as the Local Chief Executive is the proper signatory.
- 7. The ENRO, while seeking DPWH Clearance for certain permittees in his Letters dated 22 April 2021 and 19 July 2021addressed to the DE, DPWH Region IVB – Occidental Mindoro District Office (Annexes 9 and 11), it was mentioned that during a dialogue with the Provincial Governor as well as the PMRB Chairperson, among others, among the issues raised is the need to submit the said clearance.
- 8. The complainant could not be reached for his comments as efforts to locate his address by the undersigned in San Jose, Occidental Mindoro proved futile. The undersigned even went to the local Commission on Elections Office located in the San Jose Municipal Hall to inquire whether a certain Mario Ramirez, the complainant is among the registered voters.

# COMMENT:

As per field findings, there is no evidence whatsoever as to the alleged wrongdoing by the OIC, PENRO.

# **RECOMMENDATION:**

In the light of the foregoing and in view of the documents gathered, it is recommended that the subject complaint be dismissed.


