Respectfully referred herein letter dated August 27, 2021 sent thru email from the Director, Presidential Complaint Center (PCC) bearing **Code No. GL-HRI-0827-2021-051**, endorsed a *Pinagsamang Salaysay* duly subscribed dated 29 July 2021 to Head, Executive Assistant and further conveyed to the Action Center/Hotline from **Mr. Elecito F. Atilano, et al.** of San Rafael, Roxas, Oriental Mindoro re complaint against a certain DENR employees Carlota Galit and Noli Fillarca for alleged fraud, deception and accepting cash money in the amount of P1,820 without receipt as payment to survey a lot but later it was learned that the same lot was titled to another person for appropriate action, consistent with existing laws, rules and regulations. Please allow the Legal Division thru RACCs process to apply the investigation while the Daily Incident Report (DIR) of the DENR-PACC Project Kasangga: Aksyon Laban sa Korapsyon is under finalization. It should be noted also that the same concern was forwarded to PENRO Oriental Mindoro but remained unresponded as the email allegedly was changed accordingly.

Kindly inform the complainant directly of action taken in this regard furnishing the PCC, the HEA and this Office for monitoring purposes. Expeditionary action is requested in accordance with the provisions of Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 as implemented and enforced by the Anti-Red Tape Authority.
