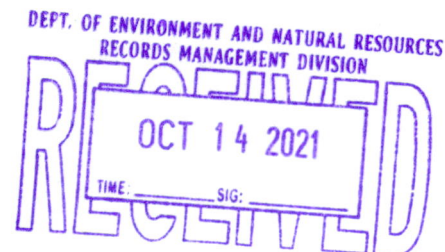

### **RESOLUTION NO. 21-09-278**

**REQUESTING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), REGIONAL OFFICE, MIMAROPA TO CONDUCT IMMEDIATE INVENTORY OF THE DOWNED TREES CAUSED BY TYPHOON URSULA IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO PARTICULARLY IN BARANGAY BENLI AND FURTHER FACILITATES THE GRANTING OF PERMIT TO CUT THEM INTO LUMBER FOR LOCAL CONSUMPTION**

**“WHEREAS**, the Department of Environment and Natural Resources is mandated to be the primary government agency responsible for the conservation, management, development and proper use of the country's environment and natural resources including those in reservations, watershed areas and lands of public domain as well as the licensing and regulation of all;

**“WHEREAS**, the onslaught of Typhoon Ursula in December, 2019 brought environmental havoc and devastation in Bulalacao. Large volume of downed timber trees provides abundant volume of woody biomass potentially available for local consumption basically for reconstruction purposes such as housing projects, livelihood assistance programs and restoration and rehabilitation of government buildings and structures which were badly damaged by typhoon;

**“WHEREAS**, in the spirit of practicality and useful purposes and for the social and economic benefits of the people and the community, it is just appreciate to cut these downed trees into lumber than to allow it to decay for nothing; **Now, therefore, be it**



**RESOLVED AS IT IS HEREBY RESOLVED, To:** Request the Department of Environment and Natural Resources (DENR), Regional Office, MIMAROPA to conduct immediate inventory of the downed trees caused by Typhoon Ursula in the Municipality of Bulalacao, Province of Oriental Mindoro particularly in Barangay Benli and further facilitates the granting of permit to cut them into lumber for local consumption;






