

Respectfully forwarded herewith are the highlights of the Administrative Hearing held on 12 July 2021 via Video Teleconferencing (Facebook Messenger Group Video Call Platform) in connection with the land claim of Mr. Fon-Tsy-Cheng-Siao in So. Tebatan, Brgy. Guadalupe, Coron, Palawan within BPR.

Please be informed that the herein administrative hearing was re-scheduled twice as indicated herein below:

- the first schedule on 05 May 2021 was postponed because of the prohibition on mass gatherings by the Municipal Mayor; and
- the second one on 09 July 2021 was cancelled due to poor internet connectivity which was supposed to be undertaken via Microsoft Teams Video Call.

During the hearing (12 July 2021), the following agreements were settled and agreed upon, to wit:

- 1. CENRO Calamianes Islands to send a letter to Mr. Fon-Tsy-Cheng-Siao, reiterating the order against him and his agents to cease the construction of the bunkhouse in the land claim. The letter to also contain the request for the following:
 - Authenticated copies of the Tax Declaration over the land claim;
 - Deed of Sale from Mr. Stephen Gaw to Mr. Fon-Tsy-Cheng-Siao;
 - Special Power of Attorney from Mr. Fon-Tsy-Cheng-Siao authorizing Mr. Gaw to transact on his behalf;

Proof of citizenship from Mr. Fon-Tsy-Cheng-Siao (e.g. birth certificate or PH passport)

Since Mr. Gaw is signifying their intent to submit themselves to the process of DENR in legitimizing their utilization of the land, a copy of an application form for an FLGMA, the application flow chart, as well as a list of the requirements. However, a Notice of Violation and a Status Quo Order should also be issued against Mr. Fon-Tsy-Cheng-Siao in the meantime.

- 2. CENRO Calamianes Islands to send a letter to Coron Municipal Assessor's Office requesting for authenticated copies of the Tax Declarations covering the land claim starting from the original holder of the said Tax Declaration. A certification from the CENRO Calamianes Islands should be attached indicating the land classification of the area (Unclassified Public Forest) and to formally request in cancelling the subject Tax Declaration. A clarification should also be sought regarding the process of cancelling Tax Declarations issued within forestlands and reservations.
- 3. CENRO Calamianes Islands to send a letter to the Chairman, Brgy. Guadalupe advising them to conduct extra due diligence in the issuance of Barangay Certifications because it turns out, Mr. Fon-Tsy-Cheng-Siao is not the actual occupant (i.e. presently residing) in the land claim. A clearance also issued by the same office states that Mr. Fon-Tsy-Cheng-Siao resides in So. Diguiboy in the same barangay when a blurry picture of the former's Tax Declaration states that he is a resident of Valenzuela City.

In this regard, attached herewith are the draft letters addressed to: Mr. Fon-Tsy-Cheng-Siao, the Coron Municipal Assessor's Office, and the Chairman of Brgy. Guadalupe, Coron.
