



It is also said that these documents were to be used in filing of Petition before the Regional Trial Court of Palawan. This Office advised Atty. Causing to request the Court to subpoena this Office to present the requested documents on the proper litigation.

As to certification of the location of Survey Authority No. H-47743 in El Nido, Palawan; this Office issued a certification to Atty. Causing for non-existence of survey authority issued for Plan H-47743. Hence, we cannot certify on its location.
