The Biodiversity Management Bureau (BMB) is currently implementing the Urban Biodiversity Program with the primary objective of enhancing and managing urban green spaces to regain ecosystem services, develop resiliency, and bring people close to nature to improve human well-being. The Urban Biodiversity Program which aims to integrate biodiversity in the local development planning process is among the thematic areas of the Philippine Strategy and Action Plan (PBSAP) 2015-2028.

Relative to this, the Bureau initiated the drafting of a Joint DENR-DILG Administrative Order to provide the institutional arrangements and mechanism for the nationwide implementation of the Urban Biodiversity Program by the local government units of urban areas. Coming at the heels of the recent *Mandanas Ruling*, the proposed policy shall provide

guidance for the LGUs to foster its environmental plans and programs towards achieving a quality environment for urban communities.
