The RDC MIMAROPA issued Memorandum No. 09-025 dated September 10, 2021 calling all concerned regional line agencies (RLAs), state universities and colleges (SUCs), government-owned and controlled corporations (GOCCs), local government units (LGUs) and other agencies to submit their priority programs and projects (PAPs) for inclusion in the RDIP, to synchronize the programming documents, with the FY 2023 budget preparation exercises. All agencies were also requested to submit the list of authorized RDIP focals to the NEDA MIMAROPA.

On September 27, 2021, the NEDA MIMAROPA conducted the online briefing on the MIMAROPA RDIP updating process, calendar of activities, and how to accomplish the RDIP matrix for the designated agency RDIP focal persons. The RDIP focals are expected to submit the updated agency investment program on or before October 07, 2021.

As such, we are inviting you and your RDIP focals to attend the abovementioned consultation workshop. The workshop aims to update and verify the list of proposed programs, projects, and activities (PPAs) submitted by the agency regional offices, government owned and controlled corporations, state universities and colleges, and local government units in support of the goals and strategies of the RDP and other regional thrusts and priorities. It also aims to identify the priority programs and projects for inclusion in the FY 2023 annual investment program.
