




## The UK Joins the Global Fund for Coral Reefs

#### Quantifying Flood Risk and Reef Risk Reduction Benefits in Florida and Puerto Rico

There is growing recognition of the role of nature-based solutions, such as coral reef restoration, to reduce coastal risks. One of the biggest limitation to advancing the use of natural defenses in coastal management, however, is the lack of quantitative assessments of their engineering performance and the social and economic benefits.

To address this limitation, the USGS, UCSC, and NOAA investigated the role of U.S. coral reefs in coastal hazard risk reduction.



Allen Coral Atlas The partners announced that after three years, 450+ research teams and counting, and two million satellite images, the habitat mapping of the world's shallow coral reefs is complete. Combined with the Atlas' monitoring system launched earlier this year, the Allen Coral Atlas is now the most complete, consistent, accurate and continually updated resource for coral scientists, policy makers and regional planners.

## Food security should open the conversation about biodiversity for coral reef-dependent countries

Led by ICRI and <u>Vulcan Inc</u>. following a call by IUCN for Open Letters to IUCN Members, Jean Weiner, Executive Director of FoProBiM, authored a moving letter regarding the importance of coral reefs for food security in the context of Haiti. The open letter calls on IUCN Members for an on-the-ground path of positive impact following the release of IUCN's Resolution 105.

"Let Resolution 105 be the starting point. It is my hope and the hope for coral reefs that IUCN, ICRI, NGOs and governments across the world will commit to on-the-ground practices to finance and develop the intended solutions. If we protect livelihoods and food security, the coexistence of people and nature is possible"

#### The Road to Kunming

The long awaited <u>draft 1 of the Global Biodiversity Framework</u> was published in July 2021 and discussed at the 3rd Open Ended Working Group that convened virtually from 23 August and recessed on the 3 September 2021.

The ICRI Post-2020 ad hoc Committee prepared an <u>initial reaction to this first</u> <u>draft</u>, proposing a number of amendments to strengthen the text of the GBF on the basis of the <u>ICRI Recommendation</u> for example increasing recognition of particularly vulnerable ecosystems; and an update of the <u>table of Recommended ICRI indicators</u> for inclusion in the monitoring framework. A number of these proposed amendments were put forward by Parties in the discussion, and will be carried forward to the next stages of the

A new element in the draft 1 GBF was the introduction of a target on restoration. Given the significance of this issue to the future of coral reef ecosystems, ICRI will hold a technical consultation to develop guidance relating to the application of this target for coral reefs and availability of suitable metrics. The aim is to ensure this is available in time for preparations of the Geneva CBD meetings provisionally scheduled for January 2022.



The KLSOF Completes the Global Reef Expedition

After traveling over 50,000 kilometers, conducting more than 12,000 scientific dives, and educating over 6,000 local students and community leaders, the Khaled bin Sultan Living Oceans Foundation has completed the Global Reef Expedition - a 10-year research mission that assessed the status and major threats to coral reefs around the world.

Using a three-pronged approach of science, education, and outreach, the <u>Global Reef Expedition</u> circumnavigated the globe, surveying and mapping over 1,000 reefs in 16 countries across the Atlantic, Pacific, and Indian Oceans as well as the Red Sea.

Reef Futures Postponed until 2022

The <u>Reef Futures</u> Planning Team has continued to track the evolution of the COVID-19 pandemic and has been actively engaged in contingency planning. International participation is essential to the CRC and over the last several weeks, we have realized that we will not be able to host an in-person gathering with robust international participation this December and the difficult decision has been made to **postpone Reef Futures to the second half of 2022**.

While rescheduling Reef Futures is not ideal, the CRC is committed to ensuring that the Symposium is a diverse event where partner organisations and CRC members from around the world can come together in-person, safely.

The Mangroves Working Group, led by <u>Friends of Ocean Action</u> in collaboration with <u>1t.org</u>, aims to raise ambition and deliver action towards the conservation and restoration of mangrove forests, by enabling companies and investors to enhance the blue carbon market with support from non-profit leaders and experts. Objectives include: delivering actions towards the group's ambition, knowledge sharing and capacity-building among members, connecting investors with projects, and, ultimately, enabling the flow of more blue carbon credits into the voluntary carbon market



## 27<sup>th</sup> June - 1<sup>th</sup> July 2022: UN Ocean Conference

The General Assembly adopted the draft decision (A/75/578) entitled "2022 United Nations Conference to Support the Implementation of Sustainable Development Goal 14: Conserve and sustainably use the oceans, seas and marine resources for sustainable development," by which the Assembly decides to convene the Conference from 27 June to 1 July 2022 in Lisbon, Portugal and that the Governments of Kenya and Portugal shall retain co-hosting responsibilities.



#### 1<sup>st</sup> - 8<sup>th</sup> September 2022: 5th International Marine Protected Area Congress (IMPAC5), Canada

The IMPAC is the top global gathering for marine conservation professionals to share knowledge, experience and best practices to strengthen marine conservation and protect the natural and cultural heritage of the world ocean. Two key focus areas for IMPAC5 are to highlight the leadership role of Indigenous Peoples in marine protected areas around the world and to engage the next generation of marine conservation professionals.
