Regina Penamora allegedly submitted to the Regional Office for approval with Subdivision Plan Lot 119-A-1 of a lot purchased in El Nido, Palawan for appropriate action, consistent with existing laws, rules and regulations. 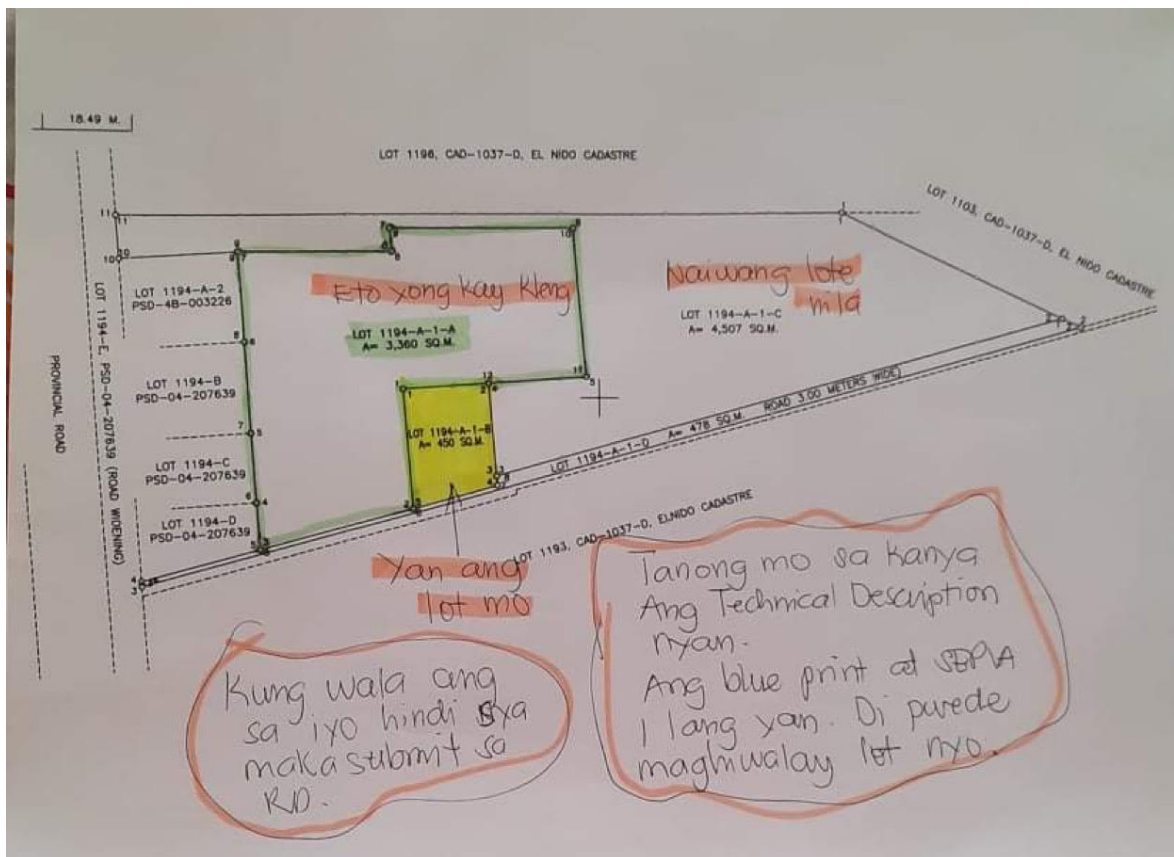
