In as much as this Office wanted to submit all the returned Public Land Applications which form part of CY 2020 and 2021 accomplishments, we are very sorry that due to the effect of the Pandemic in the present situation of the Calamianes Islands, the lacking requirements of individual applicants are not yet completed up to this writing.

People from Coron can only go to Culion or Busuanga for a day but cannot stay overnight. For overnight or more days stay, quarantine of seven (7) days is required for persons with Antigen Test result and Fourteen (14) days quarantine for persons without Antigen Test Result and must always be in Personal Protective Equipment (PPE), per Municipal Inter-Agency Task Force Orders (Coron, Culion and Busuanga) hence, mobility of our personnel is very limited.

About the pending Special Patents, this office has already communicated with the School Heads about the lacking requirements, however, no one has complied/submitted up to this writing. (Attached are copies of our letters to the School Heads for reference)
