

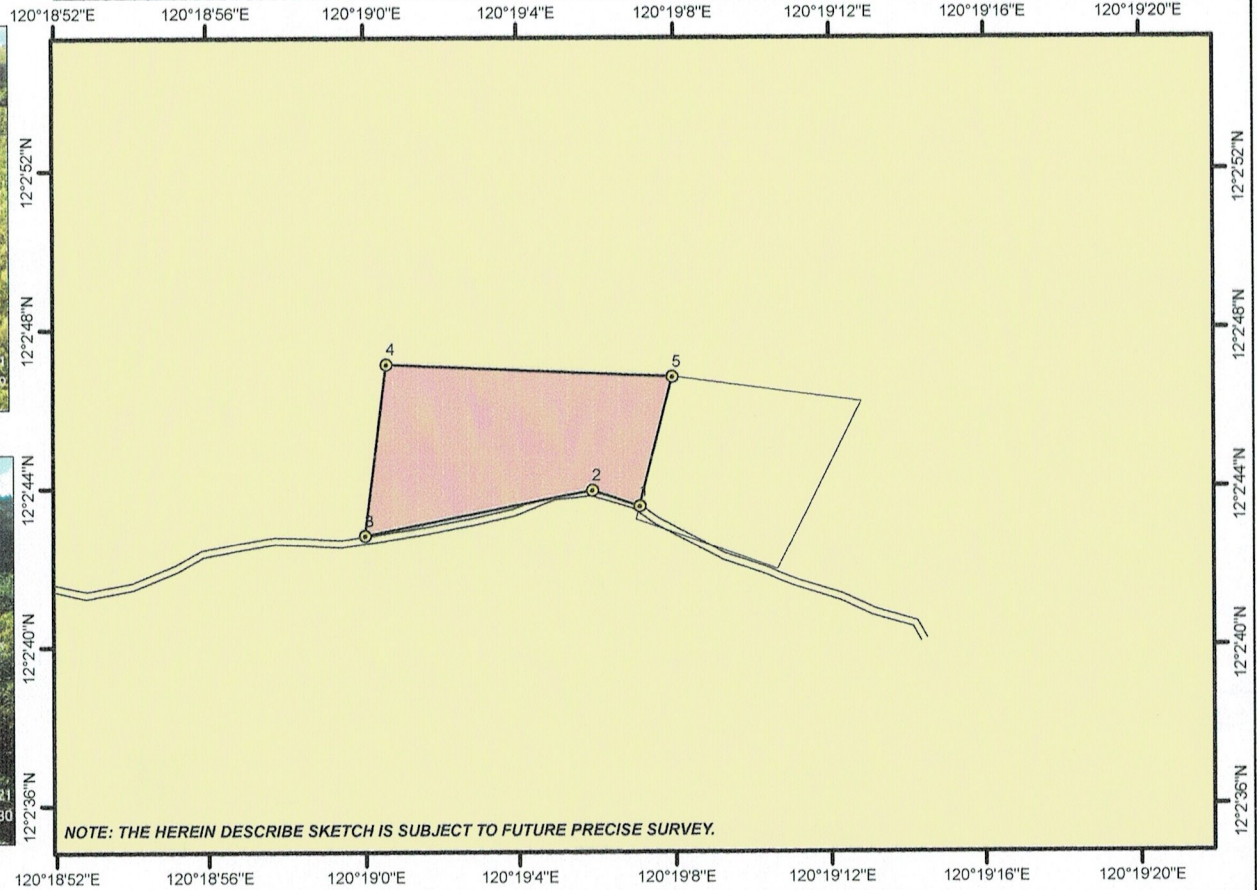

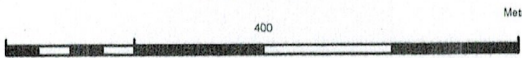

THAT this CERTIFICATE is hereby awarded to:

Goron, Palawan to develop and manage a SOCIAL FORESTRY AREA in accordance  
with the attached AGREEMENT, on a portion of forest land situated in Sitio Naaldangen,  
Barangay Borac, Municipality of Goron, Province of Palawan,  
containing an area of 4.53 hectares, more or less, bounded and described as follows:

**Bounded on the North East by Public Forest; on the South
