SUBJECT: AUTHORIZING THE CONDUCT OF ORIENTATION ON THE CRISIS KNOWLEDGE MANAGEMENT PLAN

In the interest of the service and in line with DENR Special Order No. 2021-201 which created the Crisis Management Committee (CMC) and the Crisis Knowledge Management and Data Collection Coordination Group (CKMDCCG), the conduct of the orientation on the Crisis Knowledge Management Plan (CKMP) is hereby authorized on September 16, 2021 at 8:00 a.m. to 5:00 p.m. via online conference. The conduct of the orientation shall be in accordance with the IATF Guidelines and will observe minimum health and safety requirements.

The following shall attend the orientation:

- a. Counterpart of the CMC and the CKMDCCG and officials or personnel responsible for COVID-19 crisis management in the Central Office, Bureaus, Regional Offices and Attached Agencies;
- b. Members and representatives of the CMC, Coordination Groups and Teams at the Central Office, and
- c. Other teams/personnel responsible for COVID-19 crisis management, health management and knowledge sharing.

The Coordinator of the CKMDCCG in coordination with the Human Resources Development Service (HRDS) and the GAD Office shall organize and conduct the Orientation. The HRDS through the Training and Development Division (TDD) shall facilitate the activity including engagement of a resource person on knowledge management.

All expenses that will be incurred in relation to the activity including food, supplies, materials and other incidental expenses and fees/honoraria for the resource person/s shall be charged against funds of the Knowledge and Information Systems Service (KISS) and the Strategic Communication and Initiatives Service (SCIS).

The CKMDCCG Coordinator is authorized to reschedule the date of the Orientation and issue an advisory in case of conflict with other activities of the Department, availability of the resource person or as may be warranted due to COVID-19 situation. The Deputy Coordinators of the CKMDCCG shall submit a report on the Orientation within seven (7) days after the activity.

This Order takes effect immediately.
