Dear Dir. Ferrer:

As you are most aware of, our client, Julie Gumayagay has a pending administrative complaint against **ALLAN I. VALLE**, CENRO of Taytay, Palawan filed last April 2021 for grave misconduct, gross neglect of duty, inefficiency and incompetence in the performance of his official duty RE: refusing to conduct investigation on the *questionable* approval or issuance of FP-00453320-10-208818 in favor of Susana Ma.

Considering the pendency of the administrative complaint against Mr. Valle, it is but *fair, reasonable and proper* that such investigation be conducted/handled by someone *not from CENRO* (over which he has control and supervision), but from either PENRO or the Regional Office. The law office is *not comfortable* entrusting the above-mentioned investigation to a person who himself is the subject of an administrative complaint. The mere fact that the request was **pending** at his Office for **three (3) years** without any action taken by him, is enough reason to doubt the supposed cold impartiality of Mr. Valle who in all likelihood is protecting her (Ma) via his refusal to investigate.

As records would bear out, sometime last 22 April 2021, our office acting for and in behalf of our client, **Julie Gumayagay**, filed a verified administrative complaint against **ALLAN I. VALLE, CENRO**, Taytay, Palawan, for grave misconduct, gross neglect of duty, inefficiency and incompetence in the performance of his official duty.

Despite the lapse of roughly five (5) months from date of filing of said complaint and an Order directing Mr. Valle to file his Answer to said complaint, we have **not received** any responsive pleading from said person, thus giving the impression that he is **waiving his right** to answer said complaint and therefore he may be considered to be in default.

That said, may we request that the afore-mentioned administrative complaint **be deemed submitted for Decision** based on the complaint and its attachments filed by the complainant. It is respectfully submitted that this simple complaint *need not be a protracted litigation*. It is either our complaint against Mr. Valle is valid or not. If valid, let the appropriate penalty be meted upon him. If not, let said
