Thank you for your email reply but your reply refers to a long ago November 24, 2020 email. I have recently emailed the Surveys & Mapping Division regarding specific concerns on the Nicasio Fadriquela & Dionisio Paalam lots.

May I know the current work schedule of the Surveys & Mapping Division. Are the staff reporting to work daily or on specific days only. I wish to again visit your office at Roxas Blvd and discuss in person particularly with the staff handling the survey plans of the Nicasio Fadriquela & Dionisio Paalam lots on the constraints of your office's recent requirements to support the review of those survey plans, as conveyed to me by Geodetic Engineer Marvin Bargado.

On the Nicasio Fadriquela lot, your office recently requested for an LRA certification on the status of the landholding. Upon inquiring at the LRA, the Nicasio Fadriquela lot is not in their database and they require the submission of the DENR Region 4B approved survey plan and technical description to just file a request for an LRA certification; please refer to attached copy of the LRA stub. But your office is still in the process of reviewing the survey plan. So now, there is a tug-of-war situation between the DENR Region 4B and LRA. How can we address and resolve this stand off?

On the Dionisio Paalam lot, your office is recently requiring a technical description (Form V-37) to be issued by the CENRO. But the CENRO office at Socorro, Oriental Mindoro has no data. So how shall we address and resolve this constraint?

Kindly inform me on work schedule and availability of SMD staff.
