II. The RPAB business meeting began at 10:15AM with a prayer and roll call of attendees from the RPAB members to the technical consultants present, and representatives from the proponent groups and participating local government units.

RED Gerundio first welcomed the participants and also gave a short message on the importance of the projects that will be presented for approval, particularly at this time when there is really a need to provide alternative forms of livelihood to our farmers and fisherfolk.

Before the subprojects were presented, RED Gerundio asked for updates “Upgrading of Brgy. Manoot Farm to Market Road and Construction of Manoot Bridge II”. Deputy Project Director (DPD) Engr. Annielyn Del Rosario explained that the RPCO have

submitted two communication letters to Provincial Government of Occidental Mindoro but was not receive any response after three weeks.

Compliance Officer Engr. Christian Vargas presented the communication letters to the RPAB as proof, adding that the process must be expedited to make it to the issuance of the NOL1 in September. For the subproject to not be put to waste, it was suggested for the Municipality of Rizal to submit their own proposal with the same subproject.

RED Valera of DTI suggested that the Occidental Mindoro PLGU be given a final warning with the compliance, which was seconded by I-BUILD Head Engr. Inting. Engr. Inting said that the Occidental Mindoro PLGU must be given up to five days of allowance to comply with the requirements, or else, the subproject will be handed to the MLGU of Rizal.

Compliance Officer Michael Vargas of the South Luzon Project Support Office clarified that technically speaking, based on the Operations Manual of PRPD, it is possible for an MLGU to propose a particular subproject for implementation, even if there is a pending proposal by the PLGU on the same subproject.

To resolve the matter at the soonest time possible, RED Gerundio said that he will personally speak with the governor of Occidental Mindoro to ask for his decision of whether they are still willing to take on the subproject or not. RAFC Chairman Esguerra agreed to accompany him, along with Engr. Del Rosario and Engr. Inting. For the meantime, the *“Upgrading of Brgy. Manoot Farm to Market Road and Construction of Manoot Bridge II”* was given a conditional approval by the RPAB.

A. Municipality of Rizal, Occidental Mindoro

Title: Upgrading of Brgy. Manoot Farm to Market Road and Construction of Manoot Bridge II

Cost: Php 224,953,000.00

As a matter of fact, it was already inspected and validated by the NCIP people and said that the said project is okay.

This is pursuant with the existent department order po ng DENR for all government projects, especially roads and bridges, cutting permits shall be issued to the national government agency and this time this will be the Department of Agriculture. 

There being no other matters to discuss, the business meeting was adjourned at 12:30PM.


