Magandang umaga po!

Noong April 6, 2021 nagkaroon kami ng hearing sa DENR Cenro, Roxas, Palawan ngunit wala pong ginawa na transcript. (ANNEX A)

Dahil sa nasabing pag-uusap at tulong ng CENRO personnel, pumayag po ako na idone na lang ang 1,783 sq/m na hinabol ng pamilya Rabang galing sa aking lote para sa kapayapaan ng magkatabi.

Napag-usapan naming sa hearing, matapos ang lockdown kasama ang mga CENRO Personnel at Baranggay Official magpasurvey para ibigay ko ang hinahabol nila labas na sa kanilang titulo na 4.1 hectares. *(Rabang)*

Ngunit ang masaklap habang nakalockdown umpisa ng May 11, 2021 pinangputol nila ang mga kahoy sa aking lote. *(Rabang family)*

Sinita sila ng aking caretaker at ang sagot inutusan sila ng CENRO Personnel na ROxas Palawan na magclearing ng area.

At noong May 23, 2021 ang mga pinutol na kahoy ay ginawang poste sa pagbakod ng aking lote Lot 6 sa aking subdivision plan, more or less 2 hectares kasali ang 5,000 sq/m na donated ko sa barangay at ang part ng barangay road at aking basakan. (ANNEX B and C)

Nagrequest po ako ng scaling ng mga kahoy na pinutol sa CENRO Roxas at noong July 6, 2021 sa pangunguna ni Forester I Marces Lansangen pinuntahan nila ang area at binilang ang mga kahoy na pinutol. Hinihintay ko po ang result ng scaling.

Sobra na po ito na pang-aabuso sa akin, sana po matulungan niyo ako maimbestigahan ang mga sangkot na tiwaling kawani ng gobyerno ng DENR-CENRO Roxas Palawan.
